EXPLANATORY NOTE

(This note is not part of the Order)

This Order provides for the increase of various fees payable under the Births and Deaths Registration (Northern Ireland) Order 1976 relating to searches in registers, the provision of certificates, change of name services, the provision of commemorative certificates, the individual notification of registration events and entries in the Record of Northern Ireland Connections. It also provides for the increase of various fees payable under the Marriage (Northern Ireland) Order 2003 relating to giving notice for intended marriage, the solemnisation of civil marriage and providing marriage certificates. It also provides for the various fees payable under the Civil Partnership Act 2004 relating to giving notice for intended civil partnership, the registration of civil partnership and providing civil partnership certificates.

This Order revokes and replaces the General Register Office (Fees) Order (Northern Ireland) 2010.
