EXPLANATORY MEMORANDUM TO

THE AGRICULTURE (STUDENT FEES) (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2013

2013 No. 107

1. Introduction

- 1.1. This Explanatory Memorandum has been prepared by the Department of Agriculture and Rural Development (DARD) to accompany the Statutory Regulations (details above) which are laid before the Northern Ireland Assembly.
- 1.2. The Department has made these Statutory Regulations and they are made in exercise of the powers conferred by Section 5A (1) and (2) of the Agriculture Act (Northern Ireland) 1949 as amended by Article 42(1) of the Education (Northern Ireland) Order 2006. These Regulations are subject to negative resolution.

2. Purpose

- 2.1. The Regulations amend the Agriculture (Student fees) Regulations (Northern Ireland) 2007, which sets the level of fees payable for courses of higher education delivered by DARD, at its College of Agriculture, Food and Rural Enterprise (CAFRE).
- 2.2. With effect from 1 September 2013 the fee for a student undertaking a higher education course on a full-time basis has been increased from £1,380 to £1,425.
- 2.3. The reduced fee, payable in the circumstances specified in the Agriculture (Student fees) Regulations (Northern Ireland) 2007, will increase from £680 to £700.

3. Background

- 3.1. Agri-food education provided by DARD sits outside of ambit of the Department for Employment and Learning (DEL), which has lead responsibility for further and higher education in Northern Ireland.
- 3.2. DEL operates a 2 tier fee regime which allows students to be charged a basic or a higher amount. Provision also exists for a reduced fee for sandwich courses.
- 3.3. Historically, DARD has increased its higher education tuition fees in line with the DEL basic fee (i.e. an inflation-linked increase) and the attached Regulations continue this parity with the DEL basic fee.
- 3.4. DEL introduced legislation on 1 September 2012 which allows the Higher Education Institutions in Northern Ireland to charge fees to students from England, Scotland, Wales, the Channel Islands and the Isle of Man which are higher than the tuition fees charged to local students. With effect from 1 September 2012 DARD introduced a separate fee of £9,000 per annum for full-time students from England, Scotland, Wales, the Isle of Man and the Channel

- Islands who commenced courses of higher education at CAFRE on or after 1 September 2012. This fee will remain unchanged in 2013.
- 3.5. Students undertaking a full-time higher education course can take out a Tuition Fee Loan to cover their tuition fees and a Maintenance Loan to help with their accommodation and other living costs. In addition there may be financial assistance available to students from lower income households.
- 3.6. CAFRE students may defer repayment of their Tuition Fee Loan until they are in employment and earning over £16,365 per year. This mirrors provisions made for other higher education students in Northern Ireland.
- 3.7. Income derived from student fees is used to off-set some of the costs of providing courses at CAFRE.

4. Consultation

- 4.1. DARD consulted publicly on tuition fees in 2012.
- 4.2. With regard to fees for local students, the consultation document stated that in future, it was the Department's intention to maintain parity with DEL by applying an annual inflationary increase to the fee in line with the basic fee struck by DEL. The increase holds the value of the fees constant in real terms. No respondent commented on this statement.

5. Territorial Extent and Application

5.1. This Statutory Rule applies to Northern Ireland.

6. Equality Impact

- 6.1. In accordance with DARD's obligations under Section 75 of the Northern Ireland Act 1998, the equality implications of the Regulations have been assessed and the policy has been screened out of a full equality impact assessment.
- 6.2. The Department will continue to monitor the student population at CAFRE to see if the fee increase has any material impact on the Section 75 groupings.

7. Regulatory Impact and Financial Implications

- 7.1.A Regulatory Impact Assessment has not been prepared for these Regulations as they have no impact in terms of costs on business, charities or voluntary bodies.
- 7.2. In academic year 2012/13 the fee for a full-time CAFRE higher education course was £1,380 and for sandwich courses was £680. The Agriculture (Student fees) (Amendment) Regulations (Northern Ireland) 2013 increases the fees for the academic year 2013/14 by £45 to £1,425, and for sandwich courses by £20 to £700 per year. Fees for full-time students from England, Scotland, Wales, the Channel Islands and the Isle of Man remain unchanged at £9,000 for full-time courses.

8. Section 24 of the Northern Ireland Act 1998

8.1. The Regulations increase the existing fees in line with inflation to maintain parity with the existing DEL fee regime for the academic year 2013/14, and do not have any human rights implications, nor are they incompatible with EU law. The Regulations are therefore deemed to comply with the requirements of section 24 of the Northern Ireland Act 1998.

9. EU Implications

9.1. The Regulations do not have any EU Implications. EU students will be treated the same as Northern Ireland students.

10. Additional Information

10.1. The Regulations come into operation on 1 September 2013.
