ROAD TRAFFIC AND VEHICLES

The Roads (Speed Limit) (No. 4) Order (Northern Ireland) 2013

Made - - - 19th December 2013

Coming into operation - 16th January 2014

The Department for Regional Development(\mathbf{a}) makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1)(a) of the Road Traffic Regulation (Northern Ireland) Order 1997(\mathbf{b}) and now vested in it(\mathbf{c}).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Roads (Speed Limit) (No. 4) Order (Northern Ireland) 2013 and shall come into operation on 16th January 2014.

Application of speed limits

- **2.** The driving of motor vehicles at a speed exceeding 20 miles per hour on the roads specified in Schedule 1 is prohibited.
- **3.** The driving of motor vehicles at a speed exceeding 40 miles per hour on the road and lengths of road specified in Schedule 2 is prohibited.

Revocations

4. The provisions described in Schedule 3 are revoked.

Article 2

Roads subject to a speed limit of 20 miles per hour

- 1. Castle Place, Unclassified No. 3508, Coleraine.
- 2. Laurel Avenue, Unclassified No. 3508, Coleraine.
- **3.** Somerset Drive, Unclassified No. 3508, Coleraine.
- **4.** Winston Way, Unclassified No. 3508, Coleraine.

SCHEDULE 2

Article 3

Road and Lengths of road subject to a speed limit of 40 miles per hour

- **1.** Slaght Road, Route C48, Ballymena, from a point 250 metres north-west of its junction with Cockhill Road, Unclassified No. 78, to a point 1420 metres north-west of that junction.
- **2.** Mussenden Road, Route A2, Coleraine, from its junction with Bishops Road, Unclassified No. 275, for a distance of 190 metres in a south-easterly direction.
- **3.** Seacoast Road, Route A2, Coleraine, from its junction with Bishops Road, Unclassified No. 275, for a distance of 330 metres in a westerly direction.
- **4.** Loughmuck Road, Route C0666, Omagh, from its junction with Old Dromore Road, Unclassified No. 2159, to a point 436 metres south-west of that junction.
 - **5.** Rylands Cottages, Unclassified No. 3302, Omagh, for its entire length.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order—

- (a) applies a speed limit of 20 miles per hour to the lengths of road specified in Schedule 1;
- (b) applies a speed limit of 40 miles per hour to the road and lengths of road specified in Schedule 2; and
- (c) revokes the provisions in Schedule 3.

In relation to the revoked provisions in Schedule 3—

- **1.** The speed limit on Castle Place, Coleraine (item 100 of paragraph 1 of Schedule 3) is now set at 20 miles per hour.
- **2.** The speed limit on Laurel Avenue, Coleraine (item 141 of paragraph 1 of Schedule 3) is now set at 20 miles per hour.
- **3.** The speed limit on Somerset Drive, Coleraine (item 161 of paragraph 1 of Schedule 3) is now set at 20 miles per hour.
- **4.** The speed limit on Winston Way, Coleraine (item 170 of paragraph 1 of Schedule 3) is now set at 20 miles per hour.
- **5.** The speed limit on the length of Slaght Road, Ballymena (item 10 of paragraph 2 of Schedule 3) is now included in a longer length of road set at 40 miles per hour.
- **6.** The speed limit on the length of Seacoast Road, Coleraine (item 136 of paragraph 3 of Schedule 3) is now included in a longer length of road set at 40 miles per hour.
- **7.** The speed limit on Keeragh, Pomeroy (item 1 of paragraph 4 of Schedule 3) is now set at 30 miles per hour (restricted by street lighting).
