# The Forestry (2010 Act) (Commencement No. 2) Order (Northern Ireland) 2013

*Made - - - - 11th February 2013* 

The Department of Agriculture and Rural Development, makes the following Order in exercise of the powers conferred by section 39(1) of the Forestry Act (Northern Ireland) 2010(1).

#### Citation and interpretation

- **1.**—(1) This Order may be cited as the Forestry (2010 Act) (Commencement No. 2) Order (Northern Ireland) 2013.
  - (2) In this Order "the Act" means the Forestry Act (Northern Ireland) 2010.

#### **Appointed Day**

**2.** 17th March 2013 is the day appointed for the coming into operation of the provisions of the Act listed in the Schedule.
