**The Road Traffic (Fixed Penalty) (Offences) (Amendment)
Order (Northern Ireland) 2014**

Made - - - - *18th September 2014*

Coming into operation - *31st October 2014*

The Department of the Environment makes the following Order in exercise of the powers conferred by Article 57(2) of the Road Traffic Offenders (Northern Ireland) Order 1996(a).

In accordance with Article 91(1) of that Order the Department has consulted with such representative organisations as it thinks fit.

Citation and commencement

1. This Order may be cited as the Road Traffic (Fixed Penalty) (Offences) (Amendment) Order (Northern Ireland) 2014 and shall come into operation on 31st October 2014.

Amendment of the Road Traffic (Fixed Penalty) (Offences) Order

2. In Schedule 1 to the Road Traffic (Fixed Penalty) (Offences) Order (Northern Ireland) 1997(b) (fixed penalty offences) after item 50A insert—

“Offences under the HGV
Road User Levy Act 2013

50B

Section 11

Using or keeping heavy goods
vehicle if the HGV road user
levy not paid.”

This Order amends Schedule 1 to the Road Traffic (Fixed Penalty) (Offences) Order (Northern Ireland) 1997 by specifying an additional offence under section 11 of the HGV Road Users Levy Act 2013 (C.7) to be a fixed penalty offence for the purposes of the Road Traffic Offenders (Northern Ireland) Order 1996.
