**The Social Security Pensions (Low Earnings  
Threshold) Order (Northern Ireland) 2014**

**Low earnings threshold**

2. For the purposes of the Contributions and Benefits Act<sup>(1)</sup>, it is directed that the low earnings threshold<sup>(2)</sup> for the tax years following the tax year 2013-2014 shall be £15,100.
