**The Local Government (Community Planning Partners) Order (Northern Ireland) 2016**

*Laid before the Assembly in draft*

*Made - - - - 22nd March 2016*

*Coming into operation 22nd March 2016*

The Department of the Environment makes the following Order in exercise of the powers conferred by section 67(1) of the Local Government Act (Northern Ireland) 2014<sup>(1)</sup>.

In accordance with section 67(3) of that Act, the Department has consulted the bodies specified in this Order, district councils and such other bodies and persons as the Department considers appropriate.

**Citation and commencement**

1. This Order may be cited as the Local Government (Community Planning Partners) Order (Northern Ireland) 2016 and shall come into operation on 22nd March 2016.

**Community planning partners**

2. The bodies and persons specified in the Schedule (the functions of which are exercisable in the district of a council) are the Community Planning Partners of that council.
