**The Local Government (Community Planning Partners) Order
(Northern Ireland) 2016**

Laid before the Assembly in draft

Made - - - - 22nd March 2016

Coming into operation - 15th March 2016

The Department of the Environment makes the following Order in exercise of the powers conferred by section 67(1) of the Local Government Act (Northern Ireland) 2014(a).

In accordance with section 67(3) of that Act, the Department has consulted the bodies specified in this Order, district councils and such other bodies and persons as the Department considers appropriate.

Citation and commencement

1. This Order may be cited as the Local Government (Community Planning Partners) Order (Northern Ireland) 2016 and shall come into operation on 15th March 2016.

Community planning partners

2. The bodies and persons specified in the Schedule (the functions of which are exercisable in the district of a council) are the Community Planning Partners of that council.

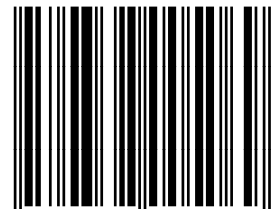
