The Rules of the Court of Judicature  
(Northern Ireland) (Amendment) 2016

Made - - - - 4th July 2016

Coming into operation in accordance with Rule 1

The Northern Ireland Court of Judicature Rules Committee<sup>(1)</sup> makes the following Rules in exercise of the powers conferred by sections 55 and 55A of the Judicature (Northern Ireland) Act 1978<sup>(2)</sup>.

**Citation, commencement and interpretation**

1.—(1) These Rules shall be cited as the Rules of the Court of Judicature (Northern Ireland) (Amendment) 2016 and shall come into operation on the same day as section 1 of the Justice Act (Northern Ireland) 2015<sup>(3)</sup>.

(2) In these Rules—

- (a) “the principal Rules” means the Rules of the Court of Judicature (Northern Ireland) 1980<sup>(4)</sup>; and
- (b) a reference to an Order, rule, Appendix or Form is a reference to that Order, rule, Appendix or Form so numbered in the principal Rules.

**Amendments to the principal Rules**

2. The principal Rules are amended as follows—

(1) In Order 95—

- (a) in rule 5(1), omit “of a county court division”; and

(2) 1978 c.23; to which the most recent relevant amendments were made by paragraphs 29 and 30 of Schedule 5 to the Constitutional Reform Act 2005 (c.4); paragraph 6 of Schedule 17, and paragraph 15 of Schedule 18, to the Northern Ireland Act 1998 (Devolution of Policing and Justice Functions) Order 2010 (S.I. 2010 No. 976); and paragraph 2 of the Schedule to the Northern Ireland (Miscellaneous Provisions) Act 2014 (c.13)

(3) 2015 c.9 (N.I.)

(4) S.R. 1980 No. 346; The Rules of the Supreme Court (Northern Ireland) 1980 were renamed in accordance with paragraph 3 of Schedule 11 to the Constitutional Reform Act 2005 (c.4). The most recent amendments were made by S.R. 2015 No. 235

- (b) in rule 6(1), omit “of a county court”.
- (2) In Order 105—
  - (a) in rule 11(4), omit “acting for the petty sessions district in which the defendant appears to be”; and
  - (b) in rule 15(3)(b), omit “acting for the petty sessions district in which the order was made”.
- (3) In Order 107, in rule 1, for the definition of “district” substitute—

““district” means a local government district within the meaning of Article 2 of and Schedule 1 to the Local Government (Boundaries) Order (Northern Ireland) 2012(5); and”.
- (4) In Order 118, in rule 10(12)(a), omit “for the petty sessions district for which that court sits”.
- (5) In Appendix A—
  - (a) in Form 37, in the heading, omit the words “for the ....of....”;
  - (b) in Forms 42 and 43, for “for the County Court Division of .....

## **EXPLANATORY NOTE**

*(This note is not part of the Rules)*

These Rules amend the Rules of the Court of Judicature (Northern Ireland) 1980 ([S.R. 1980 No. 346](#)) to take account of Part 1 of the Justice Act (Northern Ireland) 2015 which creates a single jurisdiction for county courts and magistrates' courts whereby the jurisdiction and powers of those courts are exercisable throughout the whole of Northern Ireland.
