### **JUSTICE**

The Justice Act (Northern Ireland) 2015 (Single Jurisdiction) (Consequential Amendments and Revocations) Order (Northern Ireland) 2016

Made - - - - 31st August 2016

Coming into operation in accordance with Article 1.

The Department of Justice, in exercise of the powers conferred by section 6(2) and (3) of the Justice Act (Northern Ireland) 2015(1) makes the following Order.

#### PART 1

### INTRODUCTORY

### Citation and commencement

1. This Order may be cited as the Justice Act (Northern Ireland) 2015 (Single Jurisdiction) (Consequential Amendments and Revocations) Order (Northern Ireland) 2016 and shall come into operation on the same date as section 1 of the Justice Act (Northern Ireland) 2015 comes into operation.

#### **EXPLANATORY NOTE**

(This note is not part of the Order)

Part 2 of the Order makes consequential amendments to the Orders and Regulations listed below to take account of Part 1 of and Schedule 1 to the Justice Act (Northern Ireland) 2015 ("the Act") which abolished county court divisions and petty sessions districts in Northern Ireland, and created a single territorial jurisdiction for the county courts and magistrates' courts, supported by an administrative framework:

- The Juvenile Courts and Assessors for County Courts Regulations (Northern Ireland) 1979 (S.R. 1979 No. 104);
- The Gaming Machine (Forms of Certificates and Permit) Regulations (Northern Ireland) 1986 (S.R. 1986 No. 125);
- The Gaming (Form of Bingo Club Licence) Regulations (Northern Ireland) 1987 (S.R. 1987 No. 7);
- The Lottery (Form of Certificate) Regulations (Northern Ireland) 1987 (S.R. 1987 No. 194);

Part 3 lists the Orders which are revoked in consequence of Part 1 of the Act.
