ACCESS TO JUSTICE

**The Civil Legal Services (Remuneration) (Amendment) Order
(Northern Ireland) 2016**

Made - - - - *19th September 2016*

Coming into operation - *11th October 2016*

The Department of Justice makes the following Order in exercise of the powers conferred by Articles 12(3) and 47 of the Access to Justice (Northern Ireland) Order 2003(a) and now vested in it(b).

In accordance with Article 47(2)(a) of the 2003 Order, the Department has consulted with the Lord Chief Justice, the Law Society and the General Council of the Bar of Northern Ireland.

In accordance with Article 47(1) of the 2003 Order, the Department has had regard to the matters specified in that provision.

Citation and commencement

1. This Order may be cited as the Civil Legal Services (Remuneration) (Amendment) Order (Northern Ireland) 2016 and shall come into operation on 11th October 2016.

Amendments to the Civil Legal Services (Remuneration) Order (Northern Ireland) 2015

2. Schedule 3 to the Civil Legal Services (Remuneration) Order (Northern Ireland) 2015(c) is amended as follows.

3. In Part 2, in the heading above Table 1, after “Children (Northern Ireland) Order 1995”, insert—

“or Article 31B of the Matrimonial and Family Proceedings (Northern Ireland) Order 1989(d)”.

4. In Part 3, in the heading above Table 10, after “Proceedings regarding an order under sections 89, 90, 97, 100, 104, 108, 109, 114, 118, 123, 125 or 126 of the Sexual Offences Act 2003 and Proceedings under Articles 2 and 4 of the Anti-social Behaviour (Northern Ireland) Order 2004”, insert —
