**The Rural Needs (2016 Act) (Commencement No. 2) Order  
(Northern Ireland) 2018**

The Department of Agriculture, Environment and Rural Affairs (**a**), in exercise of the powers conferred by section 5 of the Rural Needs Act (Northern Ireland) 2016 (**b**) makes the following Order.

**Citation and interpretation**

**1.** This Order may be cited as the Rural Needs (2016 Act) (Commencement No. 2) Order (Northern Ireland) 2018.

**Appointed day**

**2.** Insofar as not already in operation, the day appointed for the coming into operation of sections 1 to 4 of the Rural Needs Act (Northern Ireland) 2016, as they apply to Public Authorities listed in the Schedule to that Act, is 1st June 2018.
