**The Ship Recycling Facilities (Amendment) Regulations  
(Northern Ireland) 2018**

*Made* - - - - *4th October 2018*

*Coming into operation* - *29th October 2018*

The Department of Agriculture, Environment and Rural Affairs(a) makes the following Regulations in exercise of the powers conferred on it by section 2(2) of, and paragraph 1A of Schedule 2 to, the European Communities Act 1972(b).

The Department has been designated(c) for the purposes of section 2(2) of the European Communities Act 1972 in respect of measures relating to the prevention, reduction and elimination of pollution caused by waste and in relation to the environment.

**Citation and commencement**

1. These Regulations may be cited as the Ship Recycling Facilities (Amendment) Regulations (Northern Ireland) 2018 and shall come into operation on 29th October 2018.

**Amendment of the Ship Recycling Facilities Regulations (Northern Ireland) 2015**

2. In the Ship Recycling Facilities Regulations (Northern Ireland) 2015(d), in regulation 2 (interpretation), in the definition of “the European List”, after “established” insert “and as amended from time to time”.

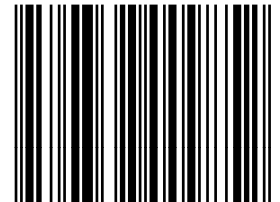
