**The U1371 (unnamed road) off Long Lane, Portadown  
(Abandonment) Order (Northern Ireland) 2018**

*Made* - - - - - *28th March 2018*

*Coming into operation* - *16th May 2018*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic to abandon the area of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

**Citation, commencement and interpretation**

**1.**—(1) This Order may be cited as The U1371 (unnamed road) off Long Lane, Portadown (Abandonment) Order (Northern Ireland) 2018 and shall come into operation on 16th May 2018.

(2) In this Order “the Contractor” means WGK Construction Limited, whose registered office is situated at 172 Ballymoney Road, Banbridge, BT32 4HW.

**Application**

**2.** The Contractor shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on completion of the works the area of road described in the Schedule shall be abandoned.

**3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

## SCHEDULE

Article 2

### AREA OF ROAD TO BE ABANDONED

An area of 364 square metres of road at the unnamed road (U1371) commencing at its junction with Long Lane, Portadown and extending for a distance of 50.83 metres in a north-westerly direction, more particularly delineated and shown hatched and coloured red on map number IN1/17/721464.

A copy of the map has been deposited at the Department's Headquarters, Room 301, Clarence Court, 10-18 Adelaide Street, Belfast and at DfI Roads Southern Division, Lands Section, Marlborough House, Central Way, Craigavon.
