# The Agriculture (Student fees)(Amendment) Regulations (Northern Ireland) 2019

The Department of Agriculture, Environment and Rural Affairs( $\mathbf{a}$ ), in exercise of the powers conferred by sections 5A(1) and (2) of the Agriculture Act (Northern Ireland) 1949( $\mathbf{b}$ ), makes the following Regulations:

#### Citation and commencement

**1.** These Regulations may be cited as the Agriculture (Student fees)(Amendment) Regulations (Northern Ireland) 2019 and shall come into operation on the 1st September 2019.

#### Amendment to the Agriculture (Student fees) Regulations (Northern Ireland) 2007

**2.** The Agriculture (Student fees) Regulations (Northern Ireland) 2007(c) shall be amended as provided by regulations 3 and 4.

**3.** In regulation 4 (1)(**d**) for "£1,645" substitute "£1,690":

**4.** In regulation 5(2)(**e**) for "£805" substitute "£825".
