The Sea Fish Industry (Coronavirus) (Fixed Costs) (Amendment) Scheme (Northern Ireland) 2020

Coming into operation - 8th June 2020

Approved by resolution of the Assembly on 7th July 2020

The Department of Agriculture, Environment and Rural Affairs(a) with the approval of the Department of Finance(b), makes the following Scheme in exercise of the powers conferred by section 15(1) and (2) of the Fisheries Act 1981(c), as read with paragraph 2(1) of Schedule 2 of the Sea Fisheries (Northern Ireland) Order 2002(d), and now vested in it(e).

Title and commencement

1. This Scheme may be cited as the Sea Fish Industry (Coronavirus) (Fixed Costs) (Amendment) Scheme (Northern Ireland) 2020 and comes into operation on 8 June 2020.

Amendment of the Sea Fish Industry (Coronavirus) (Fixed Costs) Scheme (Northern Ireland) 2020

- **2.**—(1) The Sea Fish Industry (Coronavirus) (Fixed Costs) Scheme (Northern Ireland) 2020(**f**) is amended as follows.
- (2) In Article 2(2), in the definition of "length overall" for "Council Regulation (EEC) No 2930/86"(g) substitute "Regulation (EU) 2017/1130"(h).
