The B3 Main Street, Markethill (Abandonment) Order (Northern Ireland) 2022

Made - - - - - *16th March 2022*

Coming into operation - *30th June 2022*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993^(b) and now vested in it^(c).

The Department in accordance with Article 68(4) of that Order proposes to abandon the area of road described in the Schedule as it is not necessary.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation, commencement and interpretation

1.—(1) This Order may be cited as the B3 Main Street, Markethill (Abandonment) Order (Northern Ireland) 2022 and shall come into operation on 30th June 2022.

(2) In this Order “the contractor” means Kenneth James Richardson care of The Dolphin Takeaway & Diner, 100 Main Street, Markethill, Co Armagh, BT60 1PL

Application

2. The contractor shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on completion of the works the area of road described in the Schedule shall be abandoned.

3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.
