## The Parking Places (Disabled Persons' Vehicles) (Amendment No. 6) Order (Northern Ireland) 2023

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles $10(4), 13(1)$ and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in Schedules 1 and 2 to this Order.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

One objection has been received and duly considered and no other representation has been received.

The Department has modified the draft Order.

## Citation and commencement

1. This Order may be cited as the Parking Places (Disabled Persons' Vehicles) (Amendment No. 6) Order (Northern Ireland) 2023 and shall come into operation on 1st November 2023.

## EXPLANATORY NOTE

(This note is not part of the Order)
This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule 1, the introduction of parking places with limited waiting on the lengths of road specified in Schedule 2 and the removal of the items referred to in Article 2(2)(a).
