The Tenancy Deposit Schemes (Amendment) Regulations (Northern Ireland) 2023

Made - - - - 16th February 2023
Coming into operation 1st April 2023

The Department for Communities(1) makes the following Regulations in exercise of the powers conferred on it by Article 5B(5) and (6) and Article 72(1) of the Private Tenancies (Northern Ireland) Order 2006(2).

Citation and commencement

1. These Regulations may be cited as the Tenancy Deposit Schemes (Amendment) Regulations (Northern Ireland) 2023 and come into operation on 1st April 2023.

Amendment of the Tenancy Deposit Schemes Regulations (Northern Ireland)

- **2.** The Tenancy Deposit Schemes Regulations (Northern Ireland) 2012(3) are amended in accordance with regulation 3.
 - **3.**—(1) In regulation 12 (requirement on landlord to supply information)
 - (a) In paragraph (a), for "14 days" substitute "28 days"; and
 - (b) In paragraph (b)
 - (i) For "28 days" substitute "35 days";
 - (ii) At the end insert "and any relevant person".
