ROAD TRAFFIC AND VEHICLES

The Waiting Restrictions (Eglinton) Order (Northern Ireland) 2024

Made - - - - 15th May 2024

Coming into operation 10th June 2024

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Waiting Restrictions (Eglinton) Order (Northern Ireland) 2024 and shall come into operation on 10th June 2024.
 - (2) In this Order—

"medical practitioner" means a registered person within the meaning of the Medical Act 1983(d);

"postal packet" has the same meaning as in section 65(1) Postal Services Act 2011(e); and "universal service provider" has the same meaning as in section 65(1) Postal Services Act 2011.

Restriction of waiting

2. Save as provided in Article 3, a person shall not cause or permit a vehicle to wait at any time on a length of road specified in the Schedule.

Exceptions

- **3.**—(1) Nothing in Article 2 shall render it unlawful for a person to cause or permit a vehicle to wait on the carriageway of a length of road specified in the Schedule where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident or for so long as may be reasonably necessary to enable—
 - (a) a person to board or alight from a vehicle provided that such boarding or alighting does not cause the vehicle to wait in the same place for more than 2 minutes;
 - (b) the vehicle to be used in an emergency by a medical practitioner, or for fire and rescue, ambulance, police or customs purposes or the purposes of the security forces;
 - (c) the vehicle to be used by or on behalf of a universal service provider for the purposes of the delivery to, or collection from, premises situated adjacent to the length of road of postal packets;
 - (d) the vehicle, if it cannot conveniently be used for such purposes outside that length of road, to be used—
 - (i) in connection with any building, repair or demolition operations;
 - (ii) in connection with the removal of any obstruction to traffic;
 - (iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
 - (iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of the undertaker's functions;
 - (v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992(a) or a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996(b); or
 - (vi) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in Schedule 3A to the Telecommunications Act 2003(c).
 - (e) goods to be loaded or unloaded from the vehicle.
- (2) For the purposes of paragraph 1(a) a vehicle shall be deemed to wait in the same place for more than 2 minutes if any one part of the carriageway is below any part of the vehicle or its load (if any) throughout a period exceeding 2 minutes whether or not the vehicle is moved during that period.

SCHEDULE

Article 2

WAITING RESTRICTION IN EGLINTON — No Waiting at any Time (loading and unloading permitted)

- 1. Cottage Row (west side) from a point 15 metres north of its junction with Main Street for a distance of 22 metres in a northerly direction.
- 2. Cottage Row (west side) from a point 51 metres north of its junction with Main Street for a distance of 134 metres in a northerly direction.
- 3. Main Street (south side) from a point 125 metres west of its junction with Manor Park for a distance of 6.6 metres in a westerly direction.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prohibits vehicles waiting at any time on the length of road specified in the Schedule. Vehicles are excepted from the prohibition in certain circumstances (Article 3).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of this Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Schedule to this Order will in due course be placed on the roads.
