

**Employment of Young Persons in Factories for
Explosives other than Gunpowder.**

MADE BY THE GOVERNOR AND PRIVY COUNCIL OF NORTHERN IRELAND UNDER THE EXPLOSIVES ACT, 1875 (38 & 39 VICT., C. 17), AMENDING THE ORDER IN COUNCIL OF NOVEMBER, 27, 1875 (No. 2).

Whereas by an Order in Council, dated the 27th November, 1875, and made in pursuance of the provisions of the Explosives Act, 1875, it was ordered and prescribed that certain General Rules should be observed in factories for explosives other than Gunpowder :

And whereas, in pursuance of the provisions of the Government of Ireland Act, 1920, the Explosives Act, 1875, has been adapted and modified in its application to Northern Ireland as from the 1st day of December, 1921, and the said adaptations and modifications apply to the said Order in Council as they apply to the Act under which it was made, and the said Order in Council continues in force in Northern Ireland in like manner and subject to the like powers of revocation and alteration as if it had been made under the last-mentioned Act as so adapted and modified :

And whereas it is provided by section eighty-three of the Explosives Act, 1875, as modified and adapted in its application to Northern Ireland, that the Governor of Northern Ireland may by Order in the Privy Council of Northern Ireland from time to time revoke, add to or alter any previous Order in Council under the said Act :

And whereas the provisions of Section 1 of the Rules Publication Act, 1893 (56-7 Vic., c. 66) have been complied with :

Now therefore, I, James Albert Edward, Duke of Abercorn, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland do order and prescribe that the said General Rules shall be altered as follows :—

For Rule 11 the following shall be substituted, namely :—

“(11) A person under the age of eighteen years shall not be employed in or enter any danger building except in the presence and under the supervision of some person of the age of twenty-one years or upwards, and a person under the age of sixteen years shall not be employed in any such building except in some process which has been declared by an Order made by the Ministry of Home

Affairs for Northern Ireland to be a process which is not in itself dangerous and except in the presence and under the supervision of some person of the age of twenty-one years or upwards."
