ORDER IN COUNCIL DATED 30TH MARCH, 1938, MADE UNDER SECTION SIXTY-FIVE OF THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936.

# BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND.

#### ABERCORN.

WHEREAS by section sixty-five of the Unemployment Insurance Act (Northern Ireland), 1936 (hereinafter referred to as "the Act") it is provided that in the event of an order being made at any time under Part IV of the Unemployment Insurance Act, 1935, passed by the Parliament of the United Kingdom, for the amendment of any provisions of that Act as applying to Great Britain (hereinafter referred to as a "statutory order."), then, in that event, there shall apply to Northern Ireland so much as the Governor of Northern Ireland by Order in Council declares applicable of the provisions contained in such statutory order:

AND WHEREAS it is further provided in the said section that an Order in Council thereunder may make such adaptations of any provisions contained in any statutory order as appear necessary or expedient for carrying into effect the application of those provisions to Northern Ireland, and that as from any date specified in such Order in Council the Act shall have effect subject to the provisions of the statutory order applied to Northern Ireland by such Order in Council:

AND WHEREAS a statutory order entitled the Unemployment Insurance (Additional Benefits) Order, 1938, was made on the 25th day of March, 1938, for the amendment of sections thirty-one and thirty-eight of the Unemployment Insurance Act, 1935, in their application to benefit other than agricultural benefit by increasing the maximum number of additional days of benefit payable in a benefit year and by augmenting the increase in the weekly rate of benefit payable in respect of adult dependants:

NOW, THEREFORE, I, JAMES ALBERT EDWARD, DUKE OF ABERCORN, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in pursuance of the provisions of the said section sixty-five and of all other powers enabling me in that behalf, do hereby declare that so much of the provisions contained in the aforesaid statutory order as provides for such amendment as aforesaid is applicable to Northern Ireland:

# AND I do hereby order as follows:-

- 1.—For carrying into effect the application of the said provisions to Northern Ireland, paragraph 2 of the said statutory order shall be adapted to such extent as shall be necessary so that the same may be read and have effect as follows:—
  - "2. The following amendments shall be made in the Unemployment Insurance Act (Northern Ireland), 1936:—
    - (a) In paragraph (b) of sub-section (2) of section 32, as amended by the Unemployment Insurance (Additional Days and Waiting Period) Order (Northern Ireland), 1937 (which paragraph provides for the computation of additional days of benefit), for the word 'eight' there shall be substituted the word 'ten';
    - (b) Sub-section (1) of section 39 (which relates to increase of benefit in respect of adult dependants) shall have effect as if for the words 'nine shillings' in both places where those words occur there were therein substituted the words 'ten shillings,' and accordingly paragraph (a) of subsection (2) of section 89 of the said Act (which applies with modifications the provisions of the said sub-section (1) to agricultural benefit) shall have effect as if for the 'reference in that paragraph to nine shillings there were substituted a reference to ten shillings."

2.—The date as from which the Act is to have effect subject to the provisions of the statutory order applied as aforesaid is the thirty-first day of March, 1938:

Provided that nothing contained in sub-paragraph (a) of paragraph 2 of the statutory order applied as aforesaid shall affect the computation of the maximum number of additional days in any benefit year which began before the 1st January, 1938.

- 3.—(1) This Order may be cited as the Unemployment Insurance (Additional Benefits) Order (Northern Ireland), 1938.
