**Baking Trade.**

THE TRADE BOARDS (BAKING TRADE, NORTHERN IRELAND)  
(CONSTITUTION, PROCEEDINGS AND MEETINGS) REGULATIONS,  
1938, DATED 17TH JUNE, 1938, MADE BY THE MINISTRY OF  
LABOUR UNDER SECTION 17 OF THE TRADE BOARDS ACT  
(NORTHERN IRELAND), 1923. (13 AND 14 GEO. 5, CH. 32.)

1938. No. 77.

The Ministry of Labour (in these Regulations referred to as "the Ministry") in pursuance of powers conferred by Section 17 of the Trade Boards Act (Northern Ireland), 1923, and of every other power the Ministry hereunto enabling, hereby makes the following Regulations :—

**1.**—A Trade Board (hereinafter referred to as “ the Trade Board ”) shall be established in Northern Ireland for the Baking Trade (hereinafter referred to as “ the Trade ”) as specified in the Schedule to the Trade Boards (Baking) Order (Northern Ireland), 1938, confirmed by the Trade Boards Provisional Orders Confirmation Act (Northern Ireland), 1938, and as set out in the Schedule to these Regulations.

**2.**—The Trade Board shall consist of :—

- (a) The appointed member ;
- (b) Not more than twelve members representing employers in the Trade ;
- (c) Not more than twelve members representing workers in the Trade ; and
- (d) Any additional representative members who may be appointed in accordance with the provisions of paragraph 5 of these Regulations.

**3.**—The appointed member shall be an independent person appointed by the Ministry, and shall be ex-officio Chairman of the Trade Board.

**4.**—The representative members shall be appointed by the Ministry and shall consist of members representing employers and members representing workers in equal proportions, and in making such appointments the Ministry shall pay due regard to the representation of the various branches of the Trade and of the various districts in which the Trade is carried on, and shall include one or more representatives of outworkers if a considerable proportion of outworkers is engaged in the Trade.

**5.**—The Ministry may, if the Ministry think it necessary in order to secure proper representation of any class or classes of employers or workers, after having given the Trade Board an opportunity to be heard, appoint additional representative members to serve upon the Trade Board. The number of such additional representative members shall always be an even number, not exceeding four in all. Half shall be representatives of employers and half shall be representatives of workers.

**6.**—Any member representing employers who ceases to be an employer and becomes a worker at the Trade shall vacate his seat. Any member representing workers who becomes an employer in the Trade shall vacate his seat. Whether a member representing employers or workers has vacated his seat under this clause shall be determined by the Ministry.

**7.**—Any member who, in the opinion of the Ministry, fails without reasonable cause to attend one-half of the total number of meetings in a calendar year shall vacate his seat.

**8.**—If, in the opinion of the Ministry, any member shall be incapable of acting as a member of the Trade Board, the Ministry may determine his appointment, and he shall thereupon vacate his seat.

**9.**—If the Ministry be of opinion that any member of a Trade Board has acted in a manner prejudicial to the proper conduct of the business of the Board and that he is no longer fitted to be a member of the Board, the Ministry may determine his appointment, and he shall thereupon vacate his seat.

**10.**—The term of office of a member of the Trade Board shall be for a period of not less than one year nor more than three years, as may be determined by the Ministry, provided that :—

(a) the term of office of the members of the Trade Board may, at the discretion of the Ministry, be extended for such longer period, not exceeding nine months, as it may decide, but, subject to Regulations 7, 8 and 9, the term of office of all the members of the Trade Board shall expire on the same date,

(b) a member appointed to fill a casual vacancy shall sit for the unexpired portion of the term of office of his predecessor, and

(c) a seat rendered vacant by effluxion of time shall be temporarily occupied by the retiring member until a successor be appointed.

**11.**—Any person vacating his seat on the Trade Board under any of the preceding paragraphs or for any other reason shall be eligible for reappointment as a member of the Trade Board ; and a chairman vacating his office under any of the preceding paragraphs or for any other reason shall be eligible for reappointment:

**12.**—If the chairman is temporarily unable through illness or any other cause to attend meetings of the Board, the Ministry may appoint a chairman to preside at such meetings as the Ministry may determine.

**13.**—A vacancy among members, whether arising from any cause hereinbefore mentioned or from death or from any other cause shall be filled in the same manner as in the case of the original appointment to the vacant seat, unless the Ministry otherwise determine.

**14.**—Every representative member of the Trade Board shall have one vote. If at any meeting of the Board the numbers of members present representing employers and workers, respectively, are unequal, and the members have not agreed to vote by sides, it shall be open to the side which is in the majority to arrange that one or

more of its members shall refrain from voting, so as to preserve equality. Failing such an arrangement, the chairman may, if he think it desirable, adjourn the voting on any question to another meeting of the Board.

**15.**—The chairman shall have one vote only, which shall be in the nature of a casting vote and shall be exercised, at his discretion, only when the other votes are equally divided.

**16.**—The Trade Board shall continue in existence until dissolved by order of the Ministry.

**17.**—The Trade Board may be known under the short title of “The Baking Trade Board (Northern Ireland).”

**18.**—Any question upon the construction or interpretation of these Regulations shall, in the event of dispute, be referred to the Ministry for decision.

**19.**—These Regulations may be cited as the Trade Boards (Baking Trade, Northern Ireland) (Constitution, Proceedings and Meetings) Regulations, 1938.

SCHEDULE

---

1. Subject to the provisions of this Schedule, the Baking Trade consists of the following operations :—

- (1) the making of bread, pastry, and flour confectionery and all work incidental thereto ;
- (2) the making of other articles of food and all work incidental thereto, in an undertaking, or branch or department thereof, mainly engaged on one or more of the operations specified in sub-paragraph (1) of this paragraph ;
- (3) the sale or distribution of any of the articles of food referred to in the preceding sub-paragraphs—
  - (a) by a worker mainly employed or engaged as bread-server, van-man or other like worker, including any assistant employed or engaged by or with such worker ;
  - (b) by a worker who in the same week is also engaged in any of the work specified in those sub-paragraphs ;

(4) when performed by a worker employed by an employer mainly engaged in the Baking Trade—storing, packing, unpacking, checking, loading, unloading, transporting, horse-keeping, cleaning premises, cleaning vehicles, or other operations (wherever performed) incidental to those specified in any of the preceding sub-paragraphs, or incidental to the handling of any raw materials required for the purpose of the operations specified in those sub-paragraphs.

2. Notwithstanding anything in this Schedule the following operations are not operations in the Baking Trade—

(1) the making of biscuits in an undertaking, or a branch or department of an undertaking, mainly engaged in the making of biscuits, and the making of any other article of food therein by workers mainly engaged in the making of biscuits ;

(2) the making of any of the articles of food referred to in paragraph 1. hereof—

(a) in an hotel, boarding house, restaurant, café or similar establishment—

(i) for consumption on the premises ; or

(ii) for consumption off the premises at meals served by persons ordinarily employed on the premises ;

(b) by a railway undertaking for consumption on its trains, restaurant cars, ships or premises ;

(3) the making of—

(a) meat pies, sausage rolls or similar articles of pastry (including bread for use therein) ; or

(b) bread for use in sausages or similar articles of food

in an undertaking where no bread, pastry or flour confectionery is made other than that specified in this sub-paragraph ;

(4) operations included in—

(a) the Trade Boards (Milk Distributive) Order, 1920, as amended or varied by any subsequent Order ;

(b) the Trade Boards (Sugar Confectionery and Food Preserving) Order, 1913, as amended or varied by any subsequent Order ;

(c) the transport of goods by licensed carriers or by common carriers.

3. For the purposes of this Schedule the following expressions have the meanings hereby assigned to them, that is to say—

“pastry” and “articles of pastry” include articles of food made wholly or partly of pastry ;

“meat” includes game, poultry, egg or fish ;

“flour confectionery” includes cakes, oatcakes, shortbread and biscuits ;

“biscuits” do not include oatcakes or shortbread ; and

“making” includes the packing, wrapping and other handling of the articles of food when made, before their first despatch for sale or distribution.

**19.**—The Trade Boards (Boot and Shoe Repairing Trade, Northern Ireland) (Constitution, Proceedings and Meetings) Regulations, 1925, dated 30th July, 1925 (as amended by Regulations dated 14th August, 1929), made by the Ministry of Labour under Section 17 of the Trade Boards Act (Northern Ireland), 1923, are hereby revoked, but such revocation shall not affect the validity of any proceedings of the Trade Board established under the said Regulations, or of any minimum rates fixed by the said Board and in operation at this date.

**20.**—These Regulations may be cited as the Trade Boards (Boot and Shoe Repairing Trade, Northern Ireland) (Constitution, Proceedings and Meetings) Regulations, 1938.

The Boot and Shoe Repairing Trade, that is to say:—

The repairing, wherever carried on, of boots, shoes, slippers, and all kinds of leather footwear, *including*—

(a) the taking in and giving out of such articles before and after repair when done by a worker who is in the same week also engaged in repairing as aforesaid;

(b) the making of bespoke hand-sewn, riveted, or pegged leather footwear;

*but excluding* the manufacture of leather footwear on a large scale, the repairing of saddlery and leather goods other than leather footwear, and the retailing of leather footwear.

**Reciprocal Arrangements.**

RULES MADE BY THE UNEMPLOYMENT ASSISTANCE BOARD FOR NORTHERN IRELAND UNDER SECTION 46 (1) OF THE UNEMPLOYMENT ASSISTANCE ACT (NORTHERN IRELAND), 1934.

1938. No. 34.

The Unemployment Assistance Board for Northern Ireland, to the intent that, with the consent of the Ministry of Finance, reciprocal arrangements may be made with the Unemployment Assistance Board established under Part II of the Unemployment Act, 1934, for dealing with the cases of persons transferring between Great Britain and Northern Ireland, and for determining the conditions under which such persons may be paid allowances, by virtue of the powers conferred on it by Section 46 (1) of the Unemployment Assistance Act (Northern Ireland), 1934, and of all other powers in that behalf, hereby makes the following Rules:—

1.—Reciprocal arrangements may, with the consent of the Ministry of Finance, be made by the Unemployment Assistance Board for Northern Ireland with the Unemployment Assistance
