'(3) No person shall import into Northern Ireland any cooked pickled meat, other than bacon and ham, which contains sodium or potassium nitrite in proportions exceeding two hundred parts per million calculated as sodium nitrite.''

REGULATIONS, DATED 21ST DAY OF JUNE, 1939, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 10 OF THE SAVINGS BANKS ACT, 1887, AND OTHER ENACTMENTS.

The Ministry of Finance for Northern Ireland, in exercise of the powers conferred upon it by the following enactments as the same apply in Northern Ireland, namely:—

Section 10 of the Savings Banks Act, 1887;

Section 134 of the Factory and Workshop Act, 1901;

Section 45 of the Unemployment Assistance Act (Northern Ireland), 1934;

Section 3 of the Exchequer and Financial Provisions Act (Northern Ireland), 1934;

Section 180 of the National Health Insurance Act, 1936;

Section 102 of the Unemployment Insurance Act (Northern Ireland), 1936;

Section 33 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1936;

Section 151 of the Factories Act (Northern Ireland), 1938; hereby makes the following Regulations:—

- (g) the Factories Act (Northern Ireland), 1938; shall be in the Form A set forth in the Schedule to these Regulations.
- 2.—The requisition to be made to entitle any person to obtain a certificate or certified copy of an-entry of death required for the purposes of—
 - (a) the Unemployment Assistance Act (Northern Ireland), 1934:
 - (b) Savings Certificates Regulations; or
 - (c) the Unemployment Insurance Act (Northern Ireland), 1936;

shall be in the Form B. set forth in the said Schedule.

- 3.—The requisition to be made to entitle any person to obtain a certificate or certified copy of an entry of marriage required for the purposes of—
 - (a) the Unemployment Assistance Act (Northern Ireland), 1934;
 - (b) Savings Certificates Regulations;
 - (c) the National Health Insurance Act, 1936;
 - (d) the Unemployment Insurance Art (Northern Ireland), 1936; or
 - (e) the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1936;

shall be in the Form C set forth in the said Schedule.

- 4.—The Forms A., B. and C. in the said Schedule are approved for applications for Certificates of Births, Deaths and Marriages, respectively, required under the Savings Banks Act, 1887.
- 5.—In these regulations the expression "Savings Certificates Regulations" means the regulations of the Ministry of Finance for the time being in force with respect to Ulster savings certificates issued under sub-section (2) of section one of the Exchequer Borrowing and Local Loans Act (Northern Ireland), 1922, as amended by any subsequent enactment.
- 6.—The Certificates of Births, Deaths and Marriages (Requisition) Regulations (Northern Ireland), 1934, are hereby revoked.
- 7.—These Regulations may be cited as the Certificates of Births, Deaths and Marriages (Requisition) Regulations (Northern Ireland), 1939, and shall come into force on the 1st day of July, 1939.
