

3. For the purposes of these regulations, there shall in each year be four periods of account being the quarters ending respectively on the thirty-first day of March, the thirtieth day of June, the thirtieth day of September and the thirty-first day of December.

4. These regulations may be cited as the Registration of Births and Deaths (Payment of Registrars) Regulations, 1947, and shall have effect as regards all accounts verified and signed by Superintendent Registrars on or after the 1st day of October, 1947.

Birth Certificate — Shortened Form

REGULATIONS, DATED 18TH DECEMBER, 1947, MADE BY THE REGISTRAR-GENERAL, WITH THE CONSENT OF THE GOVERNOR OF NORTHERN IRELAND, UNDER SECTION 34 OF THE BIRTHS AND DEATHS REGISTRATION ACT (IRELAND), 1880.

The Registrar-General for Northern Ireland, in exercise of the powers conferred upon him by Section 34 of the Births and Deaths Registration Act (Ireland), 1880, as extended by Section 1 of the Births and Deaths Registration Act (Northern Ireland), 1947, with the consent of the Governor of Northern Ireland, hereby makes the following Regulations :—

1. A certificate of birth issued under Section 1 of the Births and Deaths Registration Act (Northern Ireland), 1947, (hereinafter referred to as a "short birth certificate") shall be in the form set forth in the Schedule to these Regulations. :

Provided that where the short birth certificate relates to a person who was adopted under the Adoption of Children Act (Northern Ireland), 1929, the words "place of birth" shall be omitted.

2. A short birth certificate issued by the Registrar-General shall be authenticated by the Seal of the General Register Office, and a short birth certificate issued by a Superintendent Registrar or Registrar shall be authenticated by the signature of the issuing officer.

3. Where a short birth certificate is to be issued from an entry of birth, the application therefor shall contain the following particulars :—

- (a) the name and surname ;
- (b) the date and place of birth ;
- (c) the name and surname of the father ;
- (d) the name and surname, and maiden surname, of the mother.

4. Where a short birth certificate is to be issued from an entry of adoption, the application therefor shall contain the following particulars :—

- (a) the name and surname ;
- (b) the date of birth ;
- (c) the name and surname of the adopter or adopters ;
- (d) the Court by which the adoption order was made, and the date of the order.

5. A short birth certificate shall be compiled in the following manner :—

- (a) Opposite the words " Name and Surname " there shall be inserted —

- (i) If it appears from the entry of the birth that the child was legitimate, the name of the child and the surname of the father as given in the entry ;
- (ii) If it appears from the entry of the birth that the child was illegitimate, the name of the child and the surname of the mother, as given in the entry ; or, if the birth was registered on the joint information of the parents, such surname, being the surname of either parent given in the entry, as the applicant may request.
- (iii) If the surname of a parent does not appear in the entry of the birth, the name of the child as given in the entry ;
- (iv) If the short birth certificate relates to a person who was adopted under the Adoption of Children Act (Northern Ireland), 1929, the name of that person and the surname of the adopter or adopters as given in the adoption entry :

Provided that where the Adoption Order specifies that the person shall be known by a surname other than that of the adopter or adopters, such surname shall be inserted.

- (b) Opposite the words " Sex " and " Date of Birth " respectively, there shall be inserted the relative particulars as given in the entry of the birth or of the adoption.
- (c) Opposite the words " Place of Birth," where these words are included in a short birth certificate, there shall be inserted —
 - (i) Where the birth was registered as having occurred in Northern Ireland, the name of the Registrar's district in which it was registered ;

- (ii) Where the birth is recorded as having occurred on a British ship, in an aircraft, or at a place not within Northern Ireland, the relative particulars as given in the entry.

6. These Regulations may be cited as the Birth Certificate (Shortened Form) Regulations (Northern Ireland), 1947.
