THE BAKING WAGES COUNCIL (NORTHERN IRELAND) WAGES REGULATION (AMENDMENT) (No. 5) ORDER, 1949, DATED 24TH NOVEMBER, 1949, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER SECTION 10 OF THE WAGES COUNCILS ACT (NORTHERN IRELAND), 1945 (9 & 10 GEO. 6, CH. 21).

WHEREAS the Ministry of Labour and National Insurance (hereinafter referred to as "the Ministry") has received from the Baking Wages Council (Northern Ireland) wages regulation proposals for the further amendment of the Baking Wages Council (Northern Ireland) Wages Regulation (No. 1) Order, 1949 (a) (hereinafter referred to as "Order N.I. Bk. (89)") dated the 4th day of April, 1949, as amended by the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 1) Order, 1949 (b) dated the 13th day of June, 1949, and the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 4) Order, 1949 (c) dated the 27th day of July, 1949, which fixes the minimum remuneration to be paid to certain workers in relation to whom the Baking Wages Council (Northern Ireland) operates;

NOW, THEREFORE, the Ministry by virtue of section 10 of the Wages Councils Act (Northern Ireland), 1945, and of every other power in that behalf hereby makes the following Order:—

1. As from the specified date Order N.I.Bk. (89) as amended shall have effect subject to the amendments set out in the Schedule to this Order. Statutory

2. In this Order the expression "the specified date" means the 24th day of November, 1949. Provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date. Commence-
ment.

3.—(1) This Order may be cited as the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 5) Order, 1949. Short title

SCHEDULE

STATUTORY MINIMUM REMUNERATION FOR MALE AND FEMALE WORKERS EMPLOYED IN AREA A, that is, IN ESTABLISHMENTS (OTHER THAN HOME BAKERIES) IN THE COUNTY BOROUGH OF THE CITY OF BELFAST AND IN DISTRICTS SITUATE WITHIN A RADIUS OF 1.5 STATUTE MILES THEREFROM.

The Schedule to Order N.I.Bk. (89), as amended, shall be further amended as follows:—

The following new paragraph shall be inserted immediately following paragraph 5 of the said Schedule—

“SPECIAL PROVISION IN THE CASE OF CERTAIN WORKERS WHEN A CUSTOMARY HOLIDAY FALLS ON A SATURDAY

PARAGRAPH 5A.

When a customary holiday falls on a Saturday, the normal working day on each of the days Tuesday, Wednesday, Thursday and Friday in the week following such Saturday shall, in the case of a worker whose normal working week includes work on each of the week-days Monday to Saturday and whose normal hours of work on Saturday do not exceed five, be reduced by one half-hour.”
