Primary Schools (General) (Amending)

REGULATIONS, DATED 14TH JUNE, 1950, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 AND 1950, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

1950. No. 106

The Ministry of Education (hereinafter referred to as “ the Ministry ”), in pursuance of the powers vested in it by Sections 19, 83, 84, 104 and 112 of the Education Act (Northern Ireland), 1947, as amended by the Education (Miscellaneous Provisions) Act (Northern Ireland), 1950, and with the approval of the Ministry of Finance, in so far as Sections 83 and 104 are concerned, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Primary Schools (General) (Amending) Regulations (Northern Ireland), 1950.

(2) (a) Regulation 3 of these Regulations shall have effect from the 1st August, 1950.

(b) Regulations 1, 2, 4 and 5 of these Regulations shall come into effect on the date hereof.

2. In these Regulations “ the principal Regulations ” means the Primary Schools (General) Regulations, 1949.

3. Regulation 12 of the principal Regulations shall be amended by the substitution of the number “ 205 ” for the number “ 210 ” in the first and sixth lines of that Regulation.

4. Regulation 44 of and Part I (e) (ii) of the First Schedule to the principal Regulations shall be amended by the deletion of the date " 1st April, 1951 " and the substitution therefor of the date " 1st April, 1955 ".

5. Regulation 57 of the principal Regulations shall be amended by the deletion of the second paragraph of that Regulation and the substitution of the following paragraph therefor :—

" The period of such absence shall rank for increment except that when the course is such that its successful completion would qualify the teacher for admission to a higher salary scale, any absence in respect of which salary is not paid, shall not, save in exceptional circumstances, rank for increment."

REGULATIONS, DATED 1ST MAY, 1950, MADE BY THE MINISTRY OF EDUCATION UNDER SECTIONS 77 AND 104 OF THE EDUCATION ACT (NORTHERN IRELAND), 1947, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as " the Ministry "), in pursuance of the powers vested in it by Sections 77 and 104 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Scientific Research Grants Regulations (Northern Ireland), 1950.

(2) These Regulations shall come into operation on the date thereof.
