REGULATIONS, DATED 15TH DECEMBER, 1950, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1950, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

## 1950. No. 219

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 58, 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance, hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Grammar School (Grant Conditions) Amending Regulations, No. 2, 1950.
- 2.—(1) These Regulations (other than Regulations 5 and 6) shall come into operation on the date hereof.
- (2) Regulations 5 and 6 of these Regulations shall come into operation on the first day of August, 1951.
- 3. The existing Regulations hereby amended are the Grammar School (Grant Conditions) Regulations, 1948, as amended by the Grammar School (Grant Conditions) Amending Regulations, 1949, and by the Grammar School (Grant Conditions) Amending Regulations, 1950.
- 4. After Regulation 5 of the existing Regulations there shall be inserted the following Regulation:—
  - "5A.—(1) Where the managers of a voluntary school notify to the Ministry, in such manner and before such date as the Ministry may determine, that they wish the school to be classified—
    - (a) as a Group A voluntary school; or
  - (b) as a Group B voluntary school; the Ministry shall thereupon classify the school as a Group A voluntary school or, as the case may be, a Group B voluntary school, and references in these Regulations to any school so classified shall be construed accordingly. A voluntary school, the managers of which fail duly to notify the Ministry how they wish the school to be classified, shall be classified as the Ministry thinks fit.
  - (2) The income in respect of any period after the thirty-first day of July, 1951, of a Group A voluntary school produced by the tuition fees charged in respect of pupils in the secondary department shall not, without the consent of the Ministry, be devoted to expenditure which in the opinion of the Ministry is capital expenditure nor to any purpose not related to the tuition of pupils in that department ".

- 5. For Regulation 9 of the existing Regulations there shall be substituted the following Regulation:—
  - "9.—(1) The scale of fees charged by the school authorities shall be subject to the approval of the Ministry.
  - (2) There shall be charged in respect of a pupil in the secondary department of a voluntary school who is not a qualified pupil fees of an amount not less than the fees charged in respect of a qualified pupil undergoing a corresponding course in that department. In this Regulation the expression "qualified pupil" has the meaning assigned to it in the Grammar Schools (Admissions, Scholarships and Special Allowances, School Year 1950-1951) Regulations (Northern Ireland), 1950, or in any Regulations superseding those Regulations ".
- 6. After Regulation 9 of the existing Regulations (as substituted by the last preceding Regulation) there shall be inserted the following Regulation:—
  - "9A.—(1) This Regulation shall apply to a Group A voluntary school.
    - (2) The tuition fee charged in respect of pupils in the secondary department of the school —
    - (a) shall be based upon the annual income and expenditure in connection with the tuition of pupils of that department;
    - (b) shall not be subject to the approval of the local education authority; and
    - (c) may be reviewed on the initiative either of the Ministry or of the school authorities, and on any such review regard shall be had to the fee charged during the three school years immediately preceding the review, to the policy, curriculum and traditions of the school and to any special circumstances or considerations that may be relevant.
  - (3) The expenditure in connection with the tuition of pupils in the secondary department of the school may include such salaries, and such payments in respect of additional staff, as the school authorities may, subject to the approval of the Ministry, consider desirable having regard to the policy, curriculum and traditions of the school and to any other special circumstances or considerations that may be relevant:
  - (4) Where the school authorities incur or intend to incur capital expenditure they may, for the purpose of meeting such expenditure, include in the scale of fees a fee of such amount as may

be sanctioned by the Ministry. The amount of such fee shall not save in exceptional circumstances exceed £3 per annum."

## Voluntary Grammar Schools — Meals Grant Amending Regulations, 1950

REGULATIONS, DATED 14TH MARCH, 1950, MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, UNDER THE EDUCATION ACT (NORTHERN IRELAND), 1947.

## 1950. No. 51

The Ministry of Education, with the approval of the Ministry of Finance, in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Voluntary Grammar Schools Meals Grant Amending Regulations (Northern Ireland), 1950.
  - 2. These Regulations shall come into operation on 10th April, 1950.
- 3. The existing Regulations hereby amended are the Voluntary Grammar Schools Meals Grant Regulations (Northern Ireland), 1948.
- 4. The existing Regulations shall have effect as if for sub-sections (2) and (3) of Regulation 3 thereof there were substituted therefor:—
  - "(2) The grant payable for each school year or part of a school year shall be calculated on the basis of four pence for each school meal supplied during the school year or part of the school year or the cost of the overhead charges less one penny per meal supplied, whichever is the lesser.
