Methadol (6-Dimethylamino-4: 4-diphenylheptan-3-ol), its salts and any preparation, admixture, extract or other substance containing any proportion of methadol.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Educational Services (Central Council of Physical Recreation) Grant Regulations (Northern Ireland), 1950.
- (2) These Regulations shall come into operation on the date thereof.

- 2. In accordance with arrangements approved by the Ministry of Finance and subject to the requirements of these Regulations the Ministry may make grants to the Central Council of Physical Recreation (hereinafter referred to as "the Council") in respect of expenditure incurred by the Council on services provided for Northern Ireland with the approval of the Ministry.
- 3. The Council shall furnish to the Ministry each year a statement of accounts for the preceding financial year duly certified by a qualified accountant and such other information relating to the Council's work in Northern Ireland as the Ministry may from time to time require.
- 4. The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the Interpretation of an Act of the Parliament of Northern Ireland.
