- 4. For sub-paragraph (iii) of paragraph 1 (2) of the Schedule to the existing Regulations and for the proviso to that paragraph there shall be substituted the following paragraph and proviso:—
 - "(iii) the amount by which the total annual value of any scholarships, exhibitions or bursaries held by the holder under any other schemes exceeds £20:

Provided, however, that if the holder holds a State Exhibition or a University award which is considered to be of sufficient merit, the contribution shall be increased under sub-paragraph (iii) of this paragraph only by the amount by which the total annual value of the State Exhibition and other exhibitions, scholarships and bursaries held by the holder exceeds £50."

- 5. For paragraph 2 (iv) of the Schedule to the existing Regulations there shall be substituted the following paragraph:—
 - "2 (iv) an allowance in respect of approved travelling expenses
 - (a) in excess of 5/-d. per week for a student for whom an allowance is made under (ii) (a) above;
 - (b) to a student for whom an allowance is made under (ii) (b) or (ii) (c) above."
