

Coal Supply**THE COAL SUPPLY (NORTHERN IRELAND) (AMENDMENT) (No. 2) ORDER, 1952.**

In exercise of the powers under Regulations 55 and 55AA (1) of the Defence (General) Regulations, 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, (a) (as extended by the Supplies and Services (Extended Purposes) Act, 1947, (b) and the Supplies and Services (Defence Purposes) Act, 1951, (c) and continued in force by the Supplies and Services (Continuance) Order, 1951 (d)) delegated to it by instruments of delegation made respectively by the Board of Trade on 26th May, 1941, and the Minister of Fuel and Power on 16th October, 1943, under the said Regulations, as having effect as aforesaid, and of all other powers it enabling, the Ministry of Commerce for Northern Ireland (hereafter in this Order referred to as " the Ministry ") hereby makes the following Order :—

1. The Coal Supply (Northern Ireland) Order, 1951, (e) (hereafter in this Order referred to as " the principal Order ") as amended by the Coal Supply (Northern Ireland) (Amendment) (No. 1) Order, 1951 (f) shall have effect subject to the modifications specified in this Order.

2. The following paragraphs shall be substituted for paragraphs (3), (4) and (5) of Article 2 of the principal Order :—

" (3) A licence granted under paragraph (1) of this Article shall not authorise the supply of coal retail otherwise than to an occupier of premises which at the time of making such supply are specified in a list or amended list furnished to the Ministry for the purposes of the licence by the person to whom the licence is granted and retained by the Ministry as a record of the premises to which that person is authorised to supply coal by the licence.

(4) The Ministry shall maintain a register of all lists and amended lists so furnished to it which register shall be known and is in this Order referred to as the " Coal Distribution Register ".

(5) Any occupier of premises who is or becomes aware that those premises have been specified for the purpose of more than one licence current at any one time shall, within fourteen days of the date on which he became so aware, give notice in writing thereof to the Ministry at Chichester House, Chichester Street, Belfast, or other the address for the time being of the Ministry, and shall state which of the said licences he desires to authorise the supply of coal to those premises, but if the Ministry gives notice in writing to the occupier

of any premises that those premises may for the purposes of this Order be specified for the purpose of more than one licence, nothing in this paragraph shall apply in relation to any licence mentioned in that notice."

3. The following Article shall be substituted for Article 4 of the principal Order :—

" 4.—(1) No person shall acquire or offer or agree to acquire, coal retail unless he is the occupier of premises registered in the Coal Distribution Register.

(2) No person shall acquire, or offer or agree to acquire, coal retail otherwise than from the person authorised by licence to supply coal retail to the premises occupied by such first mentioned person."

4. The following Article shall be substituted for Article 5 of the principal Order :—

" 5. Where the occupier of any premises specified for the purposes of any licence desires that that specification shall cease to have effect and that the supply of coal retail to those premises shall be authorised by some other licence, and —

(a) the holders of those licences agree to the making of the change ; or

(b) failing such agreement, the Ministry, on application being made to it for the purpose, authorises the making of the change ;

the relevant lists shall be so altered as to give effect to the agreement or, as the case may be authorisation."

5. This Order shall come into operation on the first day of May, nineteen hundred and fifty-two, and may be cited as the Coal Supply (Northern Ireland) (Amendment) (No. 2) Order, 1952.
