

I, THE RIGHT HONOURABLE GEORGE B. HANNA, Q.C., Minister of Home Affairs for Northern Ireland, in pursuance of sections thirty and thirty-two of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945, do hereby make the following Regulations:—

1. In the First Schedule to the Principal Regulations (which specifies the poisons in respect of which special restrictions as to the persons to whom the poisons may be sold, and special requirements as to the keeping of records or rules, are imposed) after the item "Ketobemidone; its salts" there shall be inserted the item "Laudexium; its salts".

2. In each place in the Principal Regulations where the list of phosphorus compounds occurs the word "Sulphotepp" shall be inserted after the word "Schradan".

3. In the part of the Third Schedule to the Principal Regulations headed Group II (in which is specified in the second column the substances exempted, so far as the poisons specified in the first column are concerned, from the provisions of Part III of the Act, and from the provisions of the Principal Regulations), at the end of the entry in the second column opposite to the list of anti-histamine substances in the first column, there shall be added the words "and preparations containing not more than one per centum of anti-histamine substance for application in the nose or eye".

4. In these Regulations the expression "Principal Regulations" means the Poisons Regulations (Northern Ireland), 1954.

5. These Regulations may be cited as the Poisons Regulations (Northern Ireland), 1955, and shall come into operation on the 1st day of June, 1955.

## PRISONS

RULES, DATED 18TH DAY OF JUNE, 1955, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION THIRTEEN OF THE PRISON ACT (NORTHERN IRELAND), 1953.

The Ministry of Home Affairs for Northern Ireland, in pursuance of the powers vested in it by section thirteen of the Prison Act (Northern Ireland), 1953, and all other powers it thereunto enabling, hereby makes the following Prison Rules;—

1. Rule 48 of the Prison Rules (Northern Ireland), 1954, as amended by the Prison (Amendment) Rules (Northern Ireland), 1954, (which provides that female prisoners shall be accommodated in a prison exclusively appropriated to the detention of female prisoners, subject to exceptional circumstances) is hereby revoked.

2. The Prison (Amendment) Rules (Northern Ireland) 1954, are hereby revoked.

3. These Rules may be cited as the Prison (Amendment) Rules (Northern Ireland), 1955.

## PUBLIC HEALTH AND LOCAL GOVERNMENT

ORDER, DATED 30TH JUNE, 1955, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION TWENTY-SEVEN OF THE PUBLIC HEALTH AND LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT (NORTHERN IRELAND), 1955.

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred upon it by section twenty-seven of the Public Health and Local Government (Miscellaneous Provisions) Act (Northern Ireland), 1955 (in this Order referred to as "the Act"), hereby orders as follows:—

1. This Order may be cited as the Public Health and Local Government (Appointed Day) Order (Northern Ireland), 1955.

2. The provisions of the Act other than sections fourteen and twenty-two shall come into operation on the First day of July, 1955.

3. The provisions of section twenty-two of the Act shall come into operation on the First day of April, 1956.
