(l) Satisfactory service given as a substitute or as a locum tenens teacher.	Full credit.
(m) Such other service as in the opinion of the Ministry should be so recognised.	To such extent as the Ministry may determine.

REGULATIONS, DATED 28TH JUNE, 1957, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1956, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Primary Schools (Salaries and Allowances) Amending Regulations (Northern Ireland), 1957.

(2) Regulation 2 shall be deemed to have come into operation on 1st April, 1957.

(3) Regulation 3 shall come into operation on 1st August, 1957.

(4) Save as aforesaid these Regulations shall come into operation on the date hereof.

(5) In these Regulations the expression "the principal Regulations" means the Primary Schools (Salaries and Allowances) Regulations (Northern Ireland), 1957(a).

(6) These Regulations amend and shall be construed as one with the principal Regulations:

2. Paragraph (2) of Regulation 15 of the principal Regulations shall be amended by the deletion of the words "from 1st April following" and of the words "allocated under the table above".

3. For Regulation 23 of the principal Regulations there shall be substituted the following Regulation:—

"23.—(1) The grants payable by the Ministry in respect of the salary of a locum tenens or substitute teacher shall be in accordance with the provisions of this Regulation.

(2) Payment shall be made on a daily basis for each working day at the rate of 1/200th of the rate of salary (including any allowances payable in accordance with the provisions of these Regulations) which would be payable if he were recognised permanently in the post in which he is employed.

(3) For the purpose of this Regulation a "working day" means a day (other than a Saturday or a Sunday) on which the school was in operation or on which, though the school was not in operation, the locum tenens teacher or substitute, as the case may be, was, for a reason satisfactory to the Ministry, required to be in attendance or to hold himself available for duty at the school.

(4) In the case of any person to whom, in respect of any period of service, remuneration is paid on a daily basis in accordance with the provisions of paragraph (2) of this Regulation, each working day shall, for the purposes of the award of increment (if he is being paid salary on an incremental scale) and for such other purposes as the Ministry may determine, be reckoned as one two-hundredth of a year of service: Provided that in any twelve consecutive months any such period of service together with any other period of teaching service, which such person may perform during the said twelve consecutive months, shall not be reckoned as more than one year of service."

4. In Regulation 24 of the principal Regulations for the date "31st July, 1957" there shall be substituted the date "31st October, 1957".

These amending Regulations abolish the existing condition that a locum tenens or substitute teacher must be paid for the first 50 days of a period of employment at the minimum of the salary
