REGULATIONS DATED 20TH AUGUST, 1957, MADE BY THE MINISTER OF AGRICULTURE UNDER SECTIONS 7 AND 13 OF THE HERBAGE SEEDS ACT (NORTHERN IRELAND) 1955.

These Regulations amended the Marketing of Ryegrass Seed Regulations No. 2 (Northern Ireland) 1956, which expired on 31st August, 1957 and are not, therefore, printed at length in this volume.

# MENTAL HEALTH

## Institutions

ORDER, DATED 29TH JULY, 1957, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE MENTAL HEALTH ACT (NORTHERN IRELAND), 1948.

The Ministry of Health and Local Government (in this Order referred to as "the Ministry") in exercise of the powers conferred on it by the Mental Health Act (Northern Ireland), 1948 (in this Order referred to as "the Act"), and of all other powers enabling it in that behalf, hereby orders as follows:—

1. This Order may be cited as the Mental Health (Institutions) Order (Northern Ireland), 1957.

2. The Ministry approves of the use of that part of Armagh Chest Hospital now known as Drumarg House in the county of Armagh as an institution for the purposes of Part III of the Act.

#### MILK

REGULATIONS, DATED 31ST DAY OF JULY, 1957, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 4 OF THE MILK ACT (NORTHERN IRELAND) 1950.

The Ministry of Agriculture in exercise of the powers conferred on it by Section nine of the Milk Act (Northern Ireland) 1950, and of any other power enabling it in that behalf, hereby makes the following Regulations, that is to say:—

#### Short Title and Commencement

1. These Regulations may be cited as the Milk (Amendment) Regulations (Northern Ireland) 1957, and shall come into effect on the 2nd day of September, 1957.

2. The Milk Regulations (Northern Ireland) 1951(a) shall be amended as follows:---

(1) For Regulation 24 thereof the following regulation shall be substituted:—

"24.—(1) Grade A (T.T.) milk shall not be put into bottles or other retail containers other than on the premises of the licensed producer.

(2) Subject to the provisions of sub-paragraph 7 of this Regulation Grade A (T.T.) milk intended for sale or distribution shall, after being cooled, be put into bottles which have been washed and sterilised on the premises of the licensed producer or into other retail containers of such type as may, from time to time, be approved by the Ministry.

(3) Every bottle containing Grade A (T.T.) milk shall be tightly closed and securely fastened with a metal cap, coloured green, overlapping the lip of the bottle.

(4) Every cap shall bear the name and address of the producer and the words "Grade A (T.T.) milk" and the day of production. No other name or address shall appear on the cap.

(5) The bottle or other retail container containing Grade A (T.T.) milk may bear the name or trade name of the licensed producer or where the milk is sold by the licensed producer to a licensed distributor for resale by him, the name or trade name of such licensed distributor. In addition the bottle or other retail container may bear advertising matter intended to promote sales of liquid milk or cream, as defined in Section five of the Sale of Cream Act (Northern Ireland), 1957, where the size and design of such matter has been approved by the Ministry under Section three of the Act.

(6) The bottle or other retail container containing Grade A (T.T.) milk shall not bear any name or trade name or printing or advertising matter except as provided for in sub-paragraph (5) hereof.

(7) Where the quantity of milk intended for delivery to any one purchaser exceeds two gallons, a churn of suitable capacity which has been washed and sterilised on the premises of the licensed producer may be used for the purposes of the delivery of the milk. The churn shall be sealed, labelled with the name and address of the producer, the words "Grade A (T.T.) milk" (the letter 'A' being at least half an inch high), and the day of production with the words "morning" "evening" or "mixed milk" according to the time of milking or otherwise marked to the same effect." (2) For Regulation 32 the following regulations shall be substituted:—

"32. Every person engaged in the processes of pasteurising and/or bottling milk shall wear protective clothing.

**33.**—(1) Pasteurised milk shall not be put into bottles or other retail containers elsewhere than on the premises where it is pasteurised.

(2) Subject to the provisions of sub-paragraph (7) of this Regulation pasteurised milk intended for sale or distribution shall be put by mechanical means into bottles which have been washed and sterilised in accordance with these Regulations at the premises at which the milk is pasteurised or into other retail containers of such type as may from time to time be approved by the Ministry, and as part of a continuous process of pasteurising and filling.

Provided that this sub-paragraph shall not be deemed to prohibit the retention for a limited period of pasteurised milk in a holding vat located between the pasteurising apparatus and bottling apparatus where the said pasteurising apparatus, holding vat and bottling apparatus are linked together by enclosed connecting pipes.

(3) Every bottle shall be tightly closed and securely fastened by mechanical means with a metal cap overlapping the lip of the bottle. If any colour is used in relation to the cap that colour shall not be green.

(4) Every cap shall be marked with the name or trade name or the licence number of the holder of the distributor's licence on whose premises the milk was pasteurised and the word "pasteurised". The cap shall also be marked with the "day of delivery" being a day of the week not later than that following the day on which the milk was pasteurised.

(5) The bottle or other retail container containing pasteurised milk may bear the name or trade name of the licensed distributor on whose premises the milk was pasteurised or where the milk is sold to another licensed distributor for resale by him, the name or trade name of such distributor. In addition the bottle or other retail container may bear advertising matter intended to promote sales of liquid milk or cream, as defined in Section five of the Sale of Cream Act (Northern Ireland), 1957, where the size and design of such matter has been approved by the Ministry under Section three of the Act.

(6) The bottle or other retail container shall not bear any name or trade name or printing or advertising matter except as provided for in sub-paragraph (5) hereof.

(7) Where the quantity of milk intended for delivery to any one purchaser exceeds two gallons a churn of suitable capacity which has been washed and sterilised on the premises where the milk is pasteurised may be used for the purpose of the delivery of the milk." Sealed with the Official Seal of the Ministry of Agriculture of Northern Ireland this 31st day of July, 1957.

These amending Regulations will permit, subject to approval by the Ministry of Agriculture, the use on milk bottles of advertising material intended to promote sales of liquid milk and cream.
