

**Superannuation****Service in Schools Abroad**

RULES, DATED 31ST OCTOBER, 1957, MADE BY THE MINISTRY OF EDUCATION UNDER SECTION 19 OF THE TEACHERS (SUPERANNUATION) (AMENDMENT) ACT (NORTHERN IRELAND), 1956, WITH THE CONSENT OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in exercise of the powers conferred on it by Section 19 of the Teachers (Superannuation) (Amendment) Act (Northern Ireland), 1956, and of all other powers enabling it in that behalf, and with the consent of the Ministry of Finance, hereby makes the following rules:—

1. These rules may be cited as the Teachers (Superannuation) (Service in Schools Abroad) Rules (Northern Ireland), 1957, and shall be deemed to have come into operation on the 1st day of October, 1956.

2. In these Rules—

"the Act of 1956" means the Teachers (Superannuation) (Amendment) Act (Northern Ireland), 1956;

"the principal Act" means the Teachers (Superannuation) Act (Northern Ireland), 1950;

"financial year" means the year ending on the 31st March.

3. An application to the Ministry for a direction authorising the payment of contributions in respect of employment in a school abroad, as provided by Section 19 of the Act of 1956, shall be made in the form contained in the Schedule to these rules.

4. Contributions shall be payable in such manner and at such intervals as the Ministry may in any particular case direct.

5. The prescribed date from which compound interest shall be paid on contributions repaid under sub-section (4) of Section 19 of the Act of 1956 shall be the first day of the financial year following that in which the period of service, in respect of which they were paid, fell.

6. The provisions of Section 10 of the principal Act, of Section 16 of the Act of 1956, of Rule 8 of the Teachers Superannuation Rules, 1951(a) and of Rule 2 of the Teachers (Superannuation) Amending (No. 2) Rules (Northern Ireland), 1957, (being provisions which relate to the repayment of contributions to teachers ceasing to be employed in contributory service, or to their legal personal representatives) shall apply in relation to contributions paid by virtue of Section 19 of the Act of 1956, subject to the modification that, in calculating the balance of a

teacher's contributions, account shall not be taken of contributions paid by him in respect of the service which is treated as contributory service by virtue of the said Section 19 in excess of the amount which would have been payable by him under Section 10 of the principal Act (as amended by the Act of 1956) had that section applied in respect of that service.

EXPLANATORY NOTE

*(This note is not part of the Rules but is intended to indicate their general purport).*

Provision is made by Section 19 of the Teachers (Superannuation) (Amendment) Act (Northern Ireland), 1956, for enabling teachers who have not previously been employed in contributory service to count service in schools abroad as contributory service. The foregoing Rules provide for the payment and repayment of contributions in such cases.
