SCHEDULE

Regulation 2

**Employments which are to be included
among the insurable employments**

2. Employment—

- (a) as the Chief Clerk or the Assistant Chief Clerk or the Taxing Master or one of the several registrars of the Supreme Court of Judicature of Northern Ireland (including employment as an assistant registrar or deputy assistant registrar or district registrar); or
- (b) in the county court service for Northern Ireland in the capacity of clerk of the Crown and peace or whole time registrar.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the National Insurance (Industrial Injuries) (Insurable and Excepted Employments) Regulations (Northern Ireland), 1948, by including among the insurable employments under the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946, certain employments in connection with the Supreme Court of Judicature of Northern Ireland and in the county court service for Northern Ireland.

NATIONAL INSURANCE

Classification

REGULATIONS, DATED 22ND JULY, 1960, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1946.

The Ministry of Labour and National Insurance, in conjunction with the Ministry of Finance, in exercise of powers conferred by section 1 of the National Insurance Act (Northern Ireland), 1946(a), and of all other powers enabling it in that behalf, hereby makes the following regulations:

(a) 1946. c. 23.

Citation, interpretation and commencement

1. These regulations, which may be cited as the National Insurance (Classification) Amendment Regulations (Northern Ireland), 1960, shall be read as one with the National Insurance (Classification) Regulations (Northern Ireland), 1948(a) (hereinafter referred to as "the principal regulations"), and shall come into operation on the 1st August, 1960.

Amendment relating to certain employments in connection with the administration of justice

2. In Part I of the First Schedule(b) to the principal regulations (which Part sets out in column (A) employments in respect of which persons are treated as employed persons and in column (B) the persons excepted from the operation of column (A)) and immediately after paragraph 4, there shall be added—

(a) in column (A) the following paragraph:

"4A. Employment (not being employment under a contract of service)—

(a) as the Chief Clerk or the Assistant Chief Clerk or the Taxing Master or one of the several registrars of the Supreme Court of Judicature of Northern Ireland (including employment as an assistant registrar or deputy assistant registrar or district registrar); or

(b) in the county court service for Northern Ireland in the capacity of clerk of the Crown and peace or whole time registrar." and

(b) in column (B) the following paragraph:

"4A. None."

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the National Insurance (Classification) Regulations (Northern Ireland), 1948, by including among the employments in respect of which persons are treated as employed persons certain employments in connection with the Supreme Court of Judicature of Northern Ireland and in the county court service for Northern Ireland.
