DISABLED PERSONS (EMPLOYMENT)**Registration**

REGULATIONS, DATED 7TH MARCH, 1960, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE DISABLED PERSONS (EMPLOYMENT) ACT (NORTHERN IRELAND), 1945.

The Ministry of Labour and National Insurance, in exercise of powers conferred by sections 7(1), 8(4) and 20 of the Disabled Persons (Employment) Act (Northern Ireland), 1945(a), and of all other powers enabling it in that behalf, hereby makes the following regulations :

Citation, interpretation and commencement

1. These regulations, which may be cited as the Disabled Persons (Registration) Amendment Regulations (Northern Ireland), 1960, shall be read as one with the Disabled Persons (Registration) Regulations (Northern Ireland), 1945(b) (hereinafter referred to as "the principal regulations"), and shall come into operation on the 1st May, 1960.

Amendment of regulation 6 of the principal regulations

2. In the principal regulations paragraph (1) of regulation 6 (which provides for the disqualification from entry in the register of disabled persons of certain mentally disordered persons in Northern Ireland) is hereby revoked.

Amendment of the Schedule to the principal regulations

3. The principal regulations shall have effect as if for the form set out in Part II of the Schedule thereto there were substituted the form set out in the Schedule.

EXPLANATORY NOTE

*(This note is not part of the regulations but is intended to
indicate their general purport.)*

These Regulations amend the Disabled Persons (Registration) Regulations (Northern Ireland), 1945, which, amongst other matters, specify the disqualifications from the entry of a person's name in the register of disabled persons.

The disqualification relating to certain mentally disordered persons contained in paragraph (1) of Regulation 6 of the Regulations of 1945 is revoked.

The present Regulations also substitute a new form of application for renewal of entry of a person's name in the register of disabled persons.
