- (11) A rubber bandage or pressure bandage.
- (12) Safety pins.

#### **Building Operations (First-Aid Boxes)**

ORDER, DATED 30TH MAY, 1960, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER REGULATION 80 OF THE BUILDING REGULATIONS (NORTHERN IRELAND), 1950.

The Ministry of Labour and National Insurance for Northern Ireland in pursuance of Regulation 80 of the Building Regulations (Northern Ireland), 1950(a), hereby prescribes the equipment and materials to be contained in the first-aid boxes or cases which that Regulation requires to be provided for building sites:

## Citation, commencement and revocation

1.—(1) This Order may be cited as the Building Operations (First-Aid Boxes) Order (Northern Ireland), 1960, and shall come into operation on the 1st day of July, 1960.

(2) Article one of, and the Schedule to, the Building Operations (First-Aid and Ambulance Room Equipment) Order (Northern Ireland), 1951(a), are hereby revoked.

#### Interpretation

2. In this Order "approved" means approved for the time being by certificate of the Chief Inspector.

#### Contents of first-aid boxes or cases

3. Each first-aid box or case provided for any site shall contain the equipment and materials specified in the case of that site in the Schedule.

#### Requirements as to dressings

4. All materials for dressings contained in first-aid boxes or cases shall be those designated in, and of a grade or quality not lower than the standards specified by, the British Pharmaceutical Codex including any supplement thereto being a supplement current at the date of this Order or approved for the purposes of this Order.

- (2) A sufficient number (not less than six) of small sterilized unmedicated dressings for injured fingers.
- (3) A sufficient number (not less than three) of medium-sized sterilized unmedicated dressings for injured hands or feet.
- (4) A sufficient number (not less than three) of large sterilized unmedicated dressings for other injured parts.
- (5) A sufficient number (not less than twelve) of adhesive wound dressings of an approved type and of assorted sizes.
- (6) A sufficient number (not less than two) of triangular bandages of unbleached calico, the longest side of which measures not less than fifty-one inches and each of the other sides not less than thirty-six inches.
