Housing Subsidy Order

ORDER*, DATED 27TH NOVEMBER, 1962, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT, WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER SECTION 1 OF THE HOUSING (NO. 2) ACT (NORTHERN IRELAND), 1946.

The Ministry of Health and Local Government (in this Order referred to as "the Ministry") with the approval of the Ministry of Finance, in exercise of the powers conferred on the Ministry by section 1 of the Housing (No. 2) Act (Northern Ireland), 1946(a), and of every other power enabling it in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Housing Subsidy Order (Northern Ireland), 1962, and shall be construed as one with the Housing Subsidy Order (Northern Ireland), 1956(b) (in this Order referred to as "the principal Order").

2.—(1) This Order shall apply to a housing scheme in respect of which the tender has been submitted for approval to the Ministry after 30th November, 1962.

(2) Part II of the Housing Subsidy Order (Northern Ireland), 1961(c), shall not apply to houses to which this Order applies.

3. The principal Order shall be amended as follows:—

(1) In Article 4 the words "and description" shall be inserted after the word "area" where it first appears.

(2) In Article 5 for the sums of "twenty-one pounds" and "seven pounds" there shall be substituted respectively the sums of "twenty-four pounds" and "eight pounds".

(3) In Article 8A:—

(a) paragraph (1) shall be deleted.

(b) In paragraph (2) for the sums of "thirty-one pounds, ten shillings" and "ten pounds, ten shillings" there shall be substituted respectively the sums of "thirty-nine pounds" and "thirteen pounds".

(c) In paragraph (3) for the sums of "twenty-four pounds, ten shillings" and "eight pounds, three shillings" there shall be substituted respectively the sums of "thirty pounds" and "ten pounds".

(4) For the Second Schedule there shall be substituted the Second Schedule contained in the Schedule to this Order.
