ORDER, DATED 28TH JUNE 1963, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE CONSTRUCTION (GENERAL PROVISIONS) REGULATIONS (NORTHERN IRELAND) 1963.

The Ministry of Labour and National Insurance for Northern Ireland in pursuance of Regulations 9(3) and 18(1) of the Construction (General Provisions) Regulations (Northern Ireland) 1963(a) (hereafter in this Order referred to as "the Regulations") hereby makes the following Order:

*Citation and commencement*

1. This Order may be cited as the Construction (General Provisions) Reports Order (Northern Ireland) 1963 and shall come into operation on the 2nd day of September 1963.

*Excavations, etc., Cofferdams and Caissons*

2. A report of the results of every thorough examination—

(1) made in pursuance of paragraph (2) of Regulation 9 of the Regulations of an excavation, shaft, earthwork or tunnel; or

(2) made in pursuance of paragraph (1) of Regulation 18 of the Regulations of a cofferdam or caisson,

shall be in the form set out in the Schedule to this Order and shall contain the particulars therein specified.

## EXPLANATORY NOTE

*(This Note is not part of the Order, but is intended to indicate its general purport.)*

This Order prescribes the form of report of thorough examinations of excavations, shafts, earthworks and tunnels, and of cofferdams and caissons which examinations are required by the Construction (General Provisions) Regulations (Northern Ireland) 1963.

**Construction (Lifting Operations)—Prescribed Particulars**

ORDER, DATED 28TH JUNE 1963, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE CONSTRUCTION (LIFTING OPERATIONS) REGULATIONS (NORTHERN IRELAND) 1963.

The Ministry of Labour and National Insurance for Northern Ireland in pursuance of Regulations 28(6), 40, 41 and 46(2) of the Construction (Lifting Operations) Regulations (Northern Ireland) 1963(a) (hereafter in this Order referred to as "the Regulations") hereby makes the following Order:

*Citation and commencement*

1. This Order may be cited as the Construction (Lifting Operations) Prescribed Particulars Order (Northern Ireland) 1963; and shall come into operation on the 2nd day of September 1963.

*Cranes etc.*

2.—(1) A report of the results of every test and thorough examination—

- (a) made in pursuance of paragraph (1) of Regulation 28 of the Regulations of a crane, or
- (b) made in pursuance of paragraph (2) of that Regulation of a crane after any substantial alteration or repair affecting its strength or stability,

shall contain the particulars of the results of the test and examination specified in Part I of the Schedule to this Order.

(2) A report of the results of the test and thorough examination—

- (a) made in pursuance of paragraph (1) of Regulation 28 of the Regulations—
  - (i) of a crab or winch, or
  - (ii) of a pulley block, gin wheel or sheer legs to be used in the raising or lowering of any load weighing one ton or more, or
- (b) made in pursuance of paragraph (2) of that Regulation—
  - (i) of a crab or winch after any substantial alteration or repair affecting its strength or stability, or
