2. The Local Government (Allowances to Members) Regulations (Northern Ireland) 1955(a) shall be amended as follows:—

For paragraph 1(1) of the Second Schedule there shall be substituted—

- "(1) The rate of subsistence allowance shall not exceed—
- (a) in the case of an absence, not involving an absence overnight, from the usual place of residence—
 - (i) of more than five but not more than ten hours, 6s.;
 - (ii) of more than ten hours, 13s.;
- (b) in the case of an absence overnight from the usual place of residence—
 - (i) in Ireland, 47s.;
 - (ii) in Great Britain, 63s."

MARKETING OF POULTRY

REGULATIONS, DATED 30TH DAY OF AUGUST, 1963, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 9 OF THE MARKETING OF POULTRY ACT (NORTHERN IRELAND) 1949(b).

The Ministry of Agriculture in exercise of the powers conferred on it by Section 9 of the Marketing of Poultry Act (Northern Ireland) 1949, and of every other power enabling it in that behalf, hereby makes the following Regulations:—

Citation and Commencement

1. These Regulations may be cited as the Marketing of Poultry (Amendment No. 2) Regulations (Northern Ireland) 1963, and shall come into operation on the 1st day of October, 1963.

Amendment to the Marketing of Poultry Regulations

2. The Marketing of Poultry Regulations (Northern Ireland) 1958(a) shall be amended as follows:-

For paragraph (1) of Regulation 10 thereof the following shall be substituted: --

"10.—(1) The fees payable upon the grant or renewal of licences under Section 1 of the Act shall be as follows:—

For a Class A licence—Ten pounds. For a Class B licence—Ten pounds. For a Class C licence—Five pounds."
