# **Intermediate Schools (Grant Conditions)**

REGULATIONS, DATED 14TH MARCH, 1963, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1962, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter called "the Ministry") in pursuance of the powers vested in it by Sections 84, 104 and 112 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf and with the approval of the Ministry of Finance, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Intermediate Schools (Grant Conditions) Amending Regulations (Northern Ireland) 1963.
  - (2) These Regulations shall come into operation on 1st April, 1963.
- 2. The existing Regulations hereby amended are the Intermediate School (Grant Conditions) Regulations 1958(b).
- 3. For Regulation 18 of the existing Regulations there shall be substituted the following Regulation:—
  - "18. A teacher shall not be employed before he attains the age of 20 years or after the 31st July next following the date on which he attains the age of 65 years, except for limited periods in cases where there are special circumstances and the Ministry so approves."

#### EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

The existing Regulations provide that, except in special circumstances, a teacher shall not be employed in an intermediate school before attaining the age of eighteen or after attaining the age of sixty-five years.

These Amending Regulations raise the lower age limit for employment to twenty and extend the upper limit to 31st July next following the date on which a teacher attains the age of sixty-five.

# Grammar Schools (Grant Conditions)

- 1.—(1) These Regulations may be cited as the Grammar Schools (Grant Conditions) Amending Regulations (Northern Ireland) 1963.
  - (2) These Regulations shall come into operation on 1st April, 1963.
- 2. The existing Regulations hereby amended are the Grammar School (Grant Conditions) Regulations 1956(b).
- 3. For Regulation 20 of the existing Regulations there shall be substituted the following Regulation:—
  - "20. A teacher shall not be employed before he attains the age of 20 years or after the 31st July next following the date on which he attains the age of 65 years, except for limited periods in cases where there are special circumstances and the Ministry so approves."
