4. The Control of Fertilisers Regulations (Northern Ireland) 1954(a) are hereby revoked as from 1st June, 1963.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations exempt from the provisions of the Control of Fertilisers Act (Northern Ireland) 1953 fertilisers of such a kind and fertilisers sold in such small quantities that no grant or subsidy is payable from public monies so that vendors of the exempted fertilisers no longer require to be licensed under that Act.

The Regulations prescribe the records to be kept by persons licensed under the Act and revoke the Regulations of 1954 which prescribed a form of record no longer suitable for current requirements.

FISHERIES

Trolling Restrictions on Lower Lough Erne

Bye-Law, dated 13th February, 1963, made by the Ministry of Commerce under the Fisheries Acts (Northern Ireland), 1842 to 1954.

The Ministry of Commerce for Northern Ireland (hereinafter called "the Ministry") in exercise of its powers under Section 91 of the Fisheries (Ireland) Act, 1842(b), and of every other power enabling it in that behalf, hereby makes the following Bye-Law:—

- 1. A person shall not for the purpose of capturing fish in Lower Lough Erne by the method of "trolling", use rods or hand lines or a combination of rods and hand lines in excess of
 - (a) four in a boat occupied by three or more persons
 - (b) three in a boat occupied by two persons
 - (c) two in a boat occupied by one person.
- 2. In this Bye-Law "trolling" means the drawing of a fishing line with one or more hooks attached through the water from a moving boat.

- 3. Each and every person offending against Paragraph I shall, on conviction by a Court of Summary Jurisdiction, forfeit and pay for each offence a sum not exceeding £5 and all rods and lines or hand lines used in contravention of that paragraph shall be forfeited.
- 4. This Bye-Law may be cited as the Trolling (Lower Lough Erne) Bye-Law (Northern Ireland), 1963, and shall come into force on the first day of April, 1963.

REGULATIONS, DATED 29TH MARCH 1963, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTIONS 5, 6 AND 29 OF THE HOUSING ACT (NORTHERN IRELAND) 1945.

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred upon it by Sections 5(2), 6 and 29 of the Housing Act (Northern Ireland) 1945(a), hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Housing (Accounts) Regulations (Northern Ireland) 1963, and shall come into operation on 1st April 1963.
- 2. The Housing (Accounts) Regulations (Northern Ireland) 1947(b) shall be amended as follows:—
