OFFICE AND SHOP PREMISES**Offices at Building Operations etc. (First-aid)**

REGULATIONS, DATED 31ST MAY 1967, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER SECTION 26 OF THE OFFICE AND SHOP PREMISES ACT (NORTHERN IRELAND) 1966.

The Ministry of Health and Social Services—

- (a) in exercise of the powers conferred on it by section 26 of the Office and Shop Premises Act (Northern Ireland) 1966(a) (hereinafter referred to as "the Act of 1966") and of all other powers enabling it in that behalf, and
- (b) after publishing, pursuant to Schedule 1 to the Act, notice of the proposal to make the Regulations and not having received any objection to the draft in regard to which it is required by the said Schedule to direct an inquiry to be held,

hereby makes the following special Regulations:—

Citation and commencement

1. These Regulations may be cited as the Offices at Building Operations etc. (First-aid) Regulations (Northern Ireland) 1967 and shall come into operation on 1st June 1967.

Premises to which the Regulations apply

2. These Regulations shall apply to office premises to which the Act of 1966 applies, being premises erected—

- (a) at, or adjacent to, a place where there are carried on operations to which section 125(1) (building operations and works of engineering construction) of the Factories Act (Northern Ireland) 1965(b) (hereinafter referred to as "the Act of 1965") applies or works to which that section applies; and
- (b) for the purpose of, or in connection with, the operations or works.

Exception of premises from operation of section 24 of the Act of 1966

3. Office premises to which these Regulations apply—

- (a) shall be excepted from the operation of section 24 (first-aid: general provisions) of the Act of 1966; and
- (b) shall be deemed, for the purposes of any regulation as to first-aid made by virtue of section 125(2) of the Act of 1965 which is applicable to the place where there are carried on the operations or works for the purpose of which, or in connection with which, the premises were erected, to form part of that place.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations provide that office premises erected at, or adjacent to, a place where building operations or works of engineering construction are carried on and for the purpose of, or in connection with, the operations or works—

- (a) shall be excepted from the operation of section 24 (first-aid: general provisions) of the Office and Shop Premises Act (Northern Ireland) 1966; and
- (b) shall be deemed, for the purposes of any regulation as to first-aid made by virtue of section 125(2) of the Factories Act (Northern Ireland) 1965, to form part of the place where the operations or works are carried on.

The Lough Bradan (County Tyrone) Waterworks Joint Board

ORDER, DATED 1ST JUNE 1967, MADE BY THE MINISTRY OF DEVELOPMENT UNDER SECTION 7 OF THE WATER SUPPLIES AND SEWERAGE ACT (NORTHERN IRELAND) 1945.

Whereas the Rural Districts of Omagh, Irvinestown and Castlederg were by the Lough Bradan (County Tyrone) Waterworks Joint Board Order (Northern Ireland) 1947(a) (in this Order referred to as "the Order of 1947") formed into a united district within the meaning of section twelve of the Public Health (Ireland) Act 1878(b):

And Whereas the County Fermanagh (Transfer of Functions) Order (Northern Ireland) 1967(c) provides for the transfer on 2nd June 1967 of the functions of the Council of the Rural District of Irvinestown to the Council of the administrative County of Fermanagh:

And Whereas it is expedient to amend the Order of 1947:

Now therefore the Ministry of Development in exercise of the powers conferred on it by section seven of the Water Supplies and Sewerage Act (Northern Ireland) 1945(d) hereby orders as follows:—

1. This Order may be cited as the Lough Bradan (County Tyrone) Waterworks Joint Board (Amendment) Order (Northern Ireland) 1967.

2. This Order shall come into operation on 2nd June 1967.
