**SUMMARY JURISDICTION****Petty Sessions Districts and Times**

ORDER, DATED 8TH APRIL 1971, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 21(3) OF THE MAGISTRATES' COURTS ACT (NORTHERN IRELAND) 1964.

The Ministry of Home Affairs in exercise of the powers conferred on it by Section 21(3) of the Magistrates' Courts Act (Northern Ireland) 1964(a) and of all other powers enabling it in that behalf, after consultation with the County Court Judges and Resident Magistrates concerned, hereby orders and directs as follows:—

*Citation and commencement*

1. This Order may be cited as the Petty Sessions Districts and Times Order (Northern Ireland) 1971 and shall come into operation on the 10th day of May 1971.

*Abolition of Petty Sessions Districts of Glenarm, Keady, Comber, Greyabbey and Dungiven*

2.—(1) The Petty Sessions District of Glenarm shall be added to and become part of the Petty Sessions District of Larne and in consequence thereof the said Petty Sessions District of Glenarm is hereby abolished.

(2) The Petty Sessions District of Keady shall be added to and become part of the Petty Sessions District of Armagh and in consequence thereof the said Petty Sessions District of Keady is hereby abolished.

(3) The Petty Sessions Districts of Comber and Greyabbey shall be added to and become part of the Petty Sessions District of Newtownards and in consequence thereof the said Petty Sessions Districts of Comber and Greyabbey are hereby abolished.

(4) The Petty Sessions District of Dungiven shall be added to and become part of the Petty Sessions District of Limavady and in consequence thereof the said Petty Sessions District of Dungiven is hereby abolished.

*Times of holding of Larne, Armagh, Limavady and Newtownards Petty Sessions*

3. Petty Sessions shall be held regularly for the Larne, Armagh, Newtownards and Limavady Petty Sessions Districts at the times set out in the Schedule.

*Alteration of boundary of Larne Petty Sessions District*

4. The townland of Galbaly Lower, at present forming part of the Petty Sessions District of Cushendall, shall be added to and form part of the Petty Sessions District of Larne.

*Revocations*

5. The Petty Sessions Districts and Times (General) Order (Northern Ireland) 1967(b) in so far as it relates to Glenarm, Keady, Comber, Greyabbey and Dungiven Petty Sessions and to the times of sittings of the Petty Sessions Courts at Larne, Armagh, Limavady and Newtownards; the Petty Sessions Districts and Times (Keady) Order (Northern Ireland) 1970(c); the Petty Sessions Districts and Times (Comber and Greyabbey) Order (Northern Ireland) 1969(d); the Petty Sessions Districts and Times (Dungiven) Order (Northern Ireland) 1969(e); the Petty Sessions Districts and Times (No. 2) Order (Northern Ireland) 1970(f) in so far as it relates to Dungiven Petty Sessions, are hereby revoked.
