REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES

Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1973

Made 4th July 1973 . 1st October 1973 Coming into operation

To be laid before the Parliament of the United Kingdom under paragraph 4(5)(b) of the Schedule to the Northern Ireland (Temporary Provisions) Act 1972.

Order, dated the 4th day of July 1973, made by the Secretary of STATE UNDER SECTION 1 OF THE REGISTRATION OF BIRTHS. DEATHS AND Marriages (Fees, etc.) Act (Northern Ireland) 1955 and section 62 OF THE BIRTHS AND DEATHS REGISTRATION ACT (NORTHERN IRELAND) 1967.

WHEREAS by section 1 of the Registration of Births, Deaths and Marriages (Fees. etc.) Act (Northern Ireland) 1955(a) and by section 62 of the Births and Deaths Registration Act (Northern Ireland) 1967(b) it is, amongst other things, provided that an Order in Council prescribing the fees payable for or in respect of the solemnisation of marriages and certain matters regulated by the enactments relating to the registration of births, deaths, marriages and adoptions may be made by the Governor after a draft thereof has been approved by a resolution of each House of Parliament:

AND WHEREAS by subsection (1)(a) of section 1 of the Northern Ireland (Temporary Provisions) Act 1972(c) it is provided that so long as that section has effect all functions which apart from that Act belong to the Governor in Council shall be discharged by the Secretary of State:

Now, THEREFORE, the Secretary of State in exercise of the powers conferred upon him by section 1 of the Registration of Births, Deaths and Marriages (Fees, etc.) Act (Northern Ireland) 1955, by section 62 of the Births and Deaths Registration Act (Northern Ireland) 1967, and by section 1(1) of the Northern Ireland (Temporary Provisions) Act 1972 and of all other powers enabling him in that behalf, hereby makes the following Order:—

Citation and commencement

- 1.—(1) This Order may be cited as the Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1973.
 - (2) This Order shall come into operation on the 1st day of October 1973.

Fees payable

2. The amounts of the fees payable under the several enactments set forth in the first column of the Schedule in respect of the events and transactions described in the second column thereof shall be those specified respectively in the third column thereof.

Revocation

3. The Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1966(d) and the Births, Deaths and Marriages (Fees) Order 1970(e) are hereby revoked.
