**HEALTH AND PERSONAL SOCIAL SERVICES****Remuneration of Prescribed Persons**

REGULATIONS, DATED 28TH DECEMBER 1973, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES WITH THE APPROVAL OF THE MINISTRY OF FINANCE UNDER THE HEALTH AND PERSONAL SOCIAL SERVICES (NORTHERN IRELAND) ORDER 1972.

The Ministry of Health and Social Services (hereinafter referred to as "the Ministry") on behalf of the Secretary of State and in exercise of the powers conferred on it by Article 89 of the Health and Personal Social Services (Northern Ireland) Order 1972(a) (hereinafter referred to as "the Order") and of all other powers enabling it in that behalf and with the approval of the Ministry of Finance hereby makes the following Regulations:—

*Citation and commencement*

1. These Regulations may be cited as the Health and Personal Social Services (Remuneration of Prescribed Persons) Regulations (Northern Ireland) 1973 and shall be deemed to have come into operation on 1st October 1973.

2. The person appointed by the Minister as Chairman of the Northern Ireland Council for Nurses and Midwives by virtue of Schedule 1 to the Nurses and Midwives Act (Northern Ireland) 1970(b) shall be remunerated in accordance with determinations made by the Ministry under Article 89(1)(b) of the Order.
