Coming into force in accordance with article 1(1)

The Scottish Ministers make the following Order in exercise of the powers conferred by section 6(1)(b)(ii) and (2) of the Statistics and Registration Service Act 2007(a) and all other powers enabling them to do so.

In accordance with section 6(3) of that Act, they have consulted the Statistics Board.

In accordance with section 65(6)(a) of that Act, a draft of this instrument has been laid before and approved by resolution of the Scottish Parliament.

Citation, commencement and extent

1.—(1) This Order may be cited as the Official Statistics (Scotland) Order 2008, and comes into force on the day after the day on which it is made.

(2) It extends to Scotland, and insofar as it extends beyond Scotland, it does so only as a matter of Scots law.

2. Wholly Scottish devolved statistics(**b**) produced, or to be produced, by the persons listed in the Schedule are specified as official statistics for the purposes of section 6(1)(b) of the Statistics and Registration Service Act 2007.
