# The A956 (Aberdeen Western Peripheral Route) Special Road Scheme 2010

Laid before the Scottish Parliament 15th January 2010
Coming into force - - 2010

The Scottish Ministers make the following Scheme in exercise of the powers conferred by sections 7, 8(2) and 10(1) of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

In accordance with section 7(7) of that Act, they have given due consideration to the requirements of local and national planning, and to the requirements of agriculture and industry.

In accordance with section  $20A(\mathbf{b})$  of that Act, they have determined that the project falls within Annex I to Council Directive  $85/337/\text{EEC}(\mathbf{c})$ , as relevantly amended by Council Directive  $97/11/\text{EC}(\mathbf{d})$  and Council Directive  $2003/35/\text{EC}(\mathbf{e})$ , on the assessment of the effects of certain public and private projects on the environment.

In accordance with section 20A(2) of that Act, they have prepared an environmental statement and published notice of it on 11th September 2007, and have complied with all other provisions of section 20A of that Act.

This Scheme is made in accordance with the provisions of Parts II and III of Schedule 1(a) to that Act.

### Citation and commencement

1. This Scheme may be cited as the A956 (Aberdeen Western Peripheral Route) Special Road Scheme 2010 and comes into force on the 28th day after the day on which it is approved by resolution of the Scottish Parliament.

### Special road

**2.** The Scottish Ministers as special road authority are, by means of this Scheme, authorised to provide a special road along the route described in the Schedule and such road shall become trunk road on the date this Scheme comes into force.

### **Classes of traffic**

**3.** Classes I and II of the classes of traffic set out in Schedule 3 to the Roads (Scotland) Act 1984 are prescribed for the purpose of the use of the special road, the route of which is described in the Schedule.

# SCHEDULE SPECIAL ROAD

### INTERPRETATION

#### In this Schedule—

"the plan" means the plan numbered RYC/G109/13/0702 and entitled "The A956 (Aberdeen Western Peripheral Route) Special Road Scheme 2010", signed with reference to this Scheme and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF;

"point 1" means the existing access to Clianthus Lodge, Blairs, Aberdeen, Aberdeenshire, AB12 5YT at the existing Lochton – Auchlunies – Nigg Road (C5K), Aberdeenshire shown marked "point 1" on the plan; and

"point 2" means the junction between the existing A956 Wellington Road, Aberdeen and the existing Old Wellington Road (C8K), Aberdeen shown marked "point 2" on the plan.

### THE ROUTE OF THE SPECIAL ROAD

From a point 680 metres or thereby west of point 1 in a generally easterly then east, north-easterly direction for a distance of 6.54 kilometres or thereby to a point 750 metres or thereby west, south-west of point 2 as shown by a heavy black line between points marked "point A" and "point B" on the plan.

### **EXPLANATORY NOTE**


This Scheme at paragraph 2 authorises the Scottish Ministers, as special road authority, to provide a special road along the route described in the Schedule between Charleston and Cleanhill.

Paragraph 3 prescribes which classes of traffic are permitted to use the special road.


