Citation, commencement and interpretation

1.—(1) This Order may be cited as the Budget (Scotland) Act 2010 Amendment (No. 2) Order 2010 and comes into force on the day after the day on which it is made.

(2) In this Order, "the 2010 Act" means the Budget (Scotland) Act 2010.

Amendment of section 3 of the 2010 Act

2.—(1) Section 3 of the 2010 Act (overall cash authorisations) is amended in accordance with paragraphs (2) to (5).

(2) In paragraph (a) (in relation to the Scottish Administration)(2), for "£31,022,875,000" substitute "£31,800,947,000".

(3) In paragraph (b) (in relation to the Forestry Commissioners), for " \pounds 79,900,000" substitute " \pounds 79,946,000".

(4) In paragraph (d) (in relation to the Scottish Parliamentary Corporate Body), for "£78,554,000" substitute "£78,721,000".

(5) In paragraph (e) (in relation to Audit Scotland), for "£6,673,000" substitute "£6,919,000".

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Budget (Scotland) Act 2010 ("the 2010 Act").

This Order amends the 2010 Act so as to-

- (a) alter the overall cash authorisations in relation to the Scottish Administration, the Forestry Commissioners, the Scottish Parliamentary Corporate Body and Audit Scotland in section 3 of the 2010 Act (article 2);
- (b) alter the third and sixth purposes for which resources may be used in accordance with section 1 of and schedule 1 to the 2010 Act (article 3(2));
- (c) alter the amount of resources other than accruing resources that may be used for certain of the purposes set out in schedule 1 to the 2010 Act and the total of amounts of resources for all of the purposes (article 3(3));
- (d) alter the amount of accruing resources in respect of certain of the purposes set out in schedule 1 to the 2010 Act and the total of amounts of resources for all of the purposes (article 3(4)); and
- (e) alter the amount of resources other than accruing resources of direct-funded bodies in schedule 2 to the 2010 Act in relation to the first, third and fourth purposes (article 4(2)).
